An Act relative to certain banking laws..

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. Clause 4 of paragraph (a) of section 402 of chapter 110A of the General
- 2 Laws, as appearing in the 2008 Official Edition, is hereby amended by striking out in lines 21 to
- 3 23 the words "commonwealth, or any corporation licensed to make small loans and subject to
- 4 regulation of the commissioner of banks under chapter one hundred and forty" and inserting in
- 5 place thereof the word:-- commonwealth.
- 6 SECTION 2. Chapter 140 of the General Laws, as so appearing, is hereby amended by striking
- 7 out section 96A.
- 8 SECTION 3. Section 34C of Chapter 168 of the General Laws, as so appearing, is hereby
- 9 amended by inserting, in line 14, after the word "inclusive" the words: "and section twenty-five".

- 10 SECTION 4. Section 26C of Chapter 170 of the General Laws, as so appearing, is hereby
- amended, in line 15, by striking out the words "ten, inclusive" and inserting in place thereof the
- 12 words: "eleven, inclusive, and section fourteen".
- 13 SECTION 5. Section 58 of chapter 171 of the General Laws is hereby amended by striking out
- 14 the second paragraph.
- 15 SECTION 6. Sections 59, 59A, 60, 61, 62, 63 and 64 of chapter 171, as so appearing, are hereby
- 16 repealed.
- 17 SECTION 7. Section 78 of said chapter 171, as so appearing, is hereby amended by adding at
- 18 the end thereof the following paragraph:--
- 19 A credit union may consolidate with and into a federal credit union and a federal credit
- 20 union may consolidate with and into a credit union. In any such consolidation the credit union
- 21 shall comply with the applicable provisions of this section. A federal credit union in such a
- 22 transaction shall comply with applicable federal law.
- 23 SECTION 8. Section 63A of chapter 183 of the General Laws, as so appearing, is hereby
- 24 amended by striking out the second sentence.
