By Messrs. Vargas of Haverhill and Madaro of Boston, a petition (accompanied by bill, House, No. 3086) of Andres X. Vargas, Adrian C. Madaro and others for legislation to authorize municipalities to assess certain taxes for financing regional transportation needs and investments. Revenue.

**The Commonwealth of Massachusetts**

**In the One Hundred and Ninety-Second General Court  
(2021-2022)**

An Act relative to regional ballot initiatives.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 The General Laws are hereby amended by inserting after chapter 64M the following  
2 chapter:-

3 CHAPTER 64N.

4 LOCAL AND REGIONAL TRANSPORTATION BALLOT INITIATIVES.

5 Section 1. For purposes of this chapter, the following terms shall have the following  
6 meanings unless the context clearly requires otherwise:

7 “District agreement”, a document specifying the terms and conditions of the powers and  
8 duties of the 2 or more municipalities forming a district under section 4 of this chapter, pursuant  
9 to the laws governing any such municipality, this chapter and such procedural regulations as the  
10 commissioner of revenue may promulgate.

11 “Governing body”, in a city having a Plan D or Plan E charter the city manager and city  
12 council and in any other city the mayor and the city council and in towns the board of selectmen  
13 or equivalent body.

14 “Single subject of taxation”, 1 tax mechanism, including, sales, real or personal property,  
15 room occupancy, vehicle excise, local vehicle excise, local transportation network company  
16 surcharge, local commercial parking surcharge, or any other tax then authorized to be assessed or  
17 collected by the commonwealth or any city or town, as determined annually by the board of  
18 assessors or department of revenue, that the city or town, or district, may subject to the tax  
19 surcharge.

20 “Transportation project”, a project or program involving the planning, design or  
21 construction of public or mass transportation transit systems, transit oriented development, roads,  
22 bridges, bikeways, pedestrian pathways, and other transportation-related projects.

23 Section 2. (a) This chapter shall take effect in any city or town upon the approval of its  
24 governing body and its acceptance by the voters of any city or town by a ballot question as set  
25 forth in section 3.

26 (b) A city or town may impose any tax surcharge within its city or town on a single  
27 subject of taxation subject only to the condition that such tax is a surcharge on a tax then  
28 authorized by state law; provided, however, that no tax surcharge shall be imposed within the  
29 city or town unless it has first been approved by the governing body of such city and town and  
30 accepted by a majority of the voters of a city or town through a ballot question as set forth in  
31 section 3, except as provided in section 4.

32 (c) Notwithstanding chapters 59, 60A, 64H, 62 or any other general or special law to the  
33 contrary but subject this chapter, the governing body of any city or town may vote to accept the  
34 provisions of this chapter authorizing a surcharge on a single subject of taxation, as determined  
35 annually by the board of assessors or department of revenue. A governing body that intends to  
36 accept the provisions of this chapter shall determine prior to approval by the voters which single  
37 subject of taxation will be levied and the amount and rate of surcharge. For a real or personal  
38 property tax surcharge, the amount of the surcharge shall not be included in a calculation of total  
39 taxes assessed for purposes of section 21C of chapter 59.

40 (d) All exemptions and abatements of any single subject of taxation for which a taxpayer  
41 qualifies as eligible shall not be affected by this chapter. A taxpayer receiving an exemption for  
42 any single subject of taxation shall be exempt from any tax surcharge on any single subject of  
43 taxation established under this section. The tax surcharge to be paid by a taxpayer receiving an  
44 abatement of any single subject of taxation shall be reduced in proportion to the amount of such  
45 abatement.

46 (e) Any amount of the tax surcharge not paid by the due date shall bear interest at the rate  
47 per annum as authorized by the law for any single subject of taxation.

48 (f) Revenues raised through the tax surcharge shall be separately accounted for and used  
49 by the city or town for transportation projects.

50 Section 3. (a) Upon approval by the governing body, the actions of the governing body  
51 shall be submitted for acceptance to the voters of a city or town at the next regular municipal or  
52 state election. The city or town clerk or the state secretary shall place it on the ballot in the form  
53 of the following question: "Shall this (city or town) accept sections 2 to 5, inclusive of chapter

54 64N of the General Laws, as approved by its (governing body), a summary of which appears  
55 below

56 (Set forth here a fair, concise summary and purpose of the law to be acted upon, as  
57 determined by the city solicitor or town counsel, including in the summary the specific single  
58 subject of taxation to be levied and percentage of the surcharge to be imposed.)”

59 In the ballot question, the city or town may include a list of specific transportation  
60 projects for which the tax surcharge funds may be used, or a city or town may include a general  
61 description of the types of transportation projects for which the tax surcharge may be used. The  
62 city or town may also include a sunset provision in the ballot question, but the authorization for  
63 the tax surcharge shall not exceed 30 years.

64 If a majority of the voters voting on said question vote in the affirmative, then its  
65 provisions shall take effect in the city or town, or district as set forth under section 4, but not  
66 otherwise.

67 (b) The final date for notifying or filing a petition with the city or town clerk or the state  
68 secretary to place such a question on the ballot shall be 60 days before the city or town election  
69 or 100 days before the state election. For those petitions that will appear on the state election,  
70 notice shall be given by filing with the state secretary a certified copy of the governing body’s  
71 approval, and include a copy of the summary set forth in subsection (a).

72 (c) If the governing body does not vote to accept the provisions of this chapter, not less  
73 than 120 days before a regular city or town election or 180 days before a state election, a  
74 question seeking said acceptance through approval of a particular surcharge amount and  
75 percentage may be so placed on the ballot when a petition including information about the

76 subject of taxation, rate of taxation and project or types of projects is signed by not less than 5  
77 per cent of the registered voters of the city or town requesting such action is filed with the  
78 registrars, who shall have 7 days after receipt of such petition to certify its signatures. Upon  
79 certification of the signatures, the city or town clerk or the state secretary shall cause the question  
80 to be placed on the ballot at the next regular city or town election held more than 60 days after  
81 such certification or at the next regular state election held more than 90 days after such  
82 certification.

83           Section 4. (a) Two or more municipalities may, with the approval of the governing body  
84 of each city or town thereof, form a district for the purposes of implementing the provisions of  
85 this chapter.

86           (b) If a majority of the voters in the district, for the purposes set forth in subsection (a),  
87 vote on said question in the affirmative then the provisions of this chapter shall take effect in the  
88 district, but not otherwise.

89           (c) Two or more municipalities that choose to form a district for purposes of this chapter  
90 shall apply a tax surcharge to their preferred subject of taxation. The amount and percentage of  
91 the tax surcharge may vary for each municipality that comprises the district.

92           (d) Two or more municipalities forming a district shall adopt a district agreement with  
93 approval of the applicable governing body prior to presentment to the voters of the 2 or more  
94 municipalities by a ballot question. The district agreement shall specify: (i) the purpose and  
95 nature of the arrangement; (ii) the single municipality to serve as the treasurer of the  
96 transportation fund or the regional planning agency to serve as fiscal agent of the transportation  
97 fund under section 7 and that said municipality or regional planning agency shall also serve as

98 treasurer or fiscal agent for purposes of section 9; (iii) how the transportation fund will be used  
99 and for what purposes, and how the municipalities will decide on details of use, plan changes or  
100 urgent circumstances; (iv) the work to be performed, and the division or sharing of responsibility  
101 among the municipalities; (v) the estimated costs and the methods of financing of the  
102 transportation projects; (vi) the method of administration of the transportation fund and the  
103 transportation projects to be paid for through the fund; (vii) the composition of the district's  
104 transportation committee, the length of its term, and the criteria and method of selecting its  
105 members; (viii) the duration of the proposed agreement; and (ix) the amount, type and  
106 percentage of the tax surcharge for each municipality that comprises the district.

107 (f) Nothing in this section shall be construed to: (i) amend, repeal or otherwise alter the  
108 authority or jurisdiction of, or establish, a municipality; or (ii) confer any management authority  
109 over transportation projects beyond the authority exercised by participating municipalities in the  
110 district agreement set forth in this section and this chapter.

111 Section 5. (a) Upon acceptance of this chapter, the satisfaction of the requirements of this  
112 chapter and upon the assessors' warrant to the tax collector, the accepted tax surcharge shall be  
113 imposed. The city, town, or district, shall notify the commissioner of revenue of the date and  
114 terms on which the voters accepted this chapter.

115 (b) For a tax surcharge levied on either property or excise tax, after receipt of the warrant,  
116 the tax collector shall collect the surcharge in the amount and according to the computation  
117 specified in the warrant and shall pay the amounts so collected, quarterly or semi-annually,  
118 according to the schedule for collection of the single subject of taxation, to the city's or town's  
119 treasurer, or the district's treasurer. The tax collector shall cause appropriate books and accounts

120 to be kept with respect to such tax surcharge, which shall be subject to public examination upon  
121 reasonable request from time to time.

122 (c) Two or more municipalities forming a district shall select one of the municipalities or  
123 the regional planning agency to serve as the district's treasurer for purposes of this chapter. The  
124 district agreement shall establish the method of selecting the district treasurer. The municipality  
125 or regional planning agency selected to serve as district treasurer shall perform duties in  
126 accordance with section 5 of this chapter and chapter 41. Two or more municipalities forming a  
127 district shall also select that same municipality or regional planning agency to receive funds and  
128 provide certification for all municipalities within said district for purposes of section 9 and in  
129 accordance with section 4.

130 Section 6. (a) A city or town that accepts this chapter, either on its own or as part of a  
131 district, shall establish by ordinance or by-law and, in the case of a district, the ordinance or by-  
132 law shall be established by all member municipalities, a transportation committee not more than  
133 90 days following acceptance of this chapter. The committee shall consist of not less than 5  
134 members. The ordinance or by-law shall determine the composition of the committee, the length  
135 of its term and the criteria and method of selecting its members by appointment only. The  
136 committee shall include, but not be limited to, 1 or more representatives from the municipality, 1  
137 member of each regional transit authority to which the city or town is a member community, if  
138 any, 1 member of the regional planning agency to which the city or town is a member  
139 community and persons, as determined by the ordinance or by-law, acting in the capacity of or  
140 performing like duties of the department, board or authority if they have not been established in  
141 the city or town.



142 (b) Each transportation committee shall study the transportation-related needs,  
143 possibilities, and resources of the city, town or district. The committee shall consult with existing  
144 transportation agencies, including regional planning agencies, to develop transportation projects  
145 in accordance with the ballot initiative. If a list of transportation projects for which the tax  
146 surcharge funds may be used was included in a ballot question, the committee shall include said  
147 projects in its study; provided, however, that the committee may recommend or not recommend  
148 said projects.

149 (c) Each transportation committee shall be subject to the requirements of subsection (a)  
150 of section 19 of chapter 30A. Each transportation committee shall keep a full and accurate  
151 account of all of its actions, including its recommendations and the action taken on them and  
152 records of all appropriations or expenditures made from the Local and Regional Transportation  
153 Fund. The records and accounts of the committee shall be public records.

154 (d) Each city, town or district, as applicable, shall consult with entity proposed to own  
155 and maintain the transportation project prior to listing any transportation project on the ballot as  
156 set forth in this chapter. If a city, town or district, as applicable, includes no specific  
157 transportation projects in the ballot question, the transportation committee shall receive the  
158 approval of the regional planning agency prior to submitting the local transportation committee's  
159 recommendations to a city council or board of selectmen, unless the transportation-related  
160 project or activity is solely under local jurisdiction. The city, town, or district shall study projects  
161 that promote access to public transportation, biking, and walking.

162 (e) Not less than once every 2 fiscal years, each transportation committee shall make  
163 recommendations to the governing body of the applicable city or town or to the district regarding

164 efficient and effective ways to improve and enhance local transportation systems in such city,  
165 town or district. Recommendations to the governing body or district shall include anticipated  
166 costs over the life cycle of the transportation project. The committee may include in its  
167 recommendation to the governing body or district a recommendation to set aside for later  
168 spending funds for specific purposes that are consistent with transportation-related purposes but  
169 for which sufficient revenues are not currently available in the Local and Regional  
170 Transportation Fund, as set forth in section 7, to accomplish that specific purpose, to satisfy debt  
171 payments incurred from transportation-related projects or to set aside for later spending funds for  
172 general purposes that are consistent with transportation improvements and in accordance with the  
173 ballot initiative.

174 (f) After receiving such recommendations from the transportation committee, the  
175 governing body or district shall take such action and approve such appropriations from the Local  
176 and Regional Transportation Fund as may be necessary and appropriate for the recommendations  
177 of the transportation committee, and such additional appropriations as it deems appropriate to  
178 carry out the recommendations of the transportation committee and in accordance with the ballot  
179 initiative.

180 Section 7. (a) Notwithstanding section 53 of chapter 44 or any other general or special  
181 law to the contrary, a city, town or district that accepts the provisions of this chapter shall  
182 establish a separate account to be known as the Local and Regional Transportation Fund, of  
183 which the municipal treasurer or fiscal agent shall be the custodian. The authority to approve  
184 expenditures from the fund shall be limited to the governing body or any city or town, or the  
185 designated municipality treasurer or regional planning agency of the district, as applicable, and  
186 the municipal treasurer or fiscal agent shall pay such expenditures in accordance with chapter 41.

187 (b) Two or more municipalities forming a district shall select 1 of the municipalities or  
188 regional planning agency to establish a separate account known as the Local and Regional  
189 Transportation Fund. The municipality or regional planning agency selected to establish said  
190 fund shall only use the funds for the district as a whole through the designated fiscal agent and  
191 based solely upon the recommendations and approvals of the transportation committee as set  
192 forth in this chapter. Administration of the fund by the fiscal agent may, at the option of the  
193 governing body of any member city or town, be subject to the further approval of such governing  
194 body.

195 (c) The following monies shall be deposited in the Local and Regional Transportation  
196 Fund: (i) all funds collected from the tax surcharge on any single subject of taxation pursuant to  
197 section 3, except if the single subject of taxation is a tax collected at the state level which shall be  
198 deposited with the department of revenue in accordance with sections 8 and 9; and (ii) all funds  
199 received from the commonwealth or any other source for such purposes. The treasurer or fiscal  
200 agent may deposit or invest the proceeds of the fund in savings banks, trust companies  
201 incorporated under the laws of the commonwealth, banking companies incorporated under the  
202 laws of the commonwealth that are members of the Federal Deposit Insurance Corporation or  
203 national banks, or may invest the proceeds in paid up shares and accounts of and in co-operative  
204 banks or in shares of savings and loan associations or in shares of federal savings and loan  
205 associations doing business in the commonwealth or in the manner authorized by section 54 of  
206 chapter 44 and any income therefrom shall be credited to the fund. The expenditure of revenues  
207 from the fund shall be limited to implementing the recommendations of the transportation  
208 committees, to providing administrative and operating expenses to the committees, and in  
209 accordance with the ballot initiative. The city or town, or the municipality treasurer or regional

210 planning agency of the district as set forth in section 4, shall be prohibited from diverting  
211 revenues derived from the tax surcharge into any other fund created by law or ordinance.

212 (d) Only those cities and towns or districts that adopt the tax surcharge allowed by this  
213 chapter shall be eligible to receive monies through the Local and Regional Transportation Fund.

214 Section 8. (a) There shall be established and set up on the books of the commonwealth a  
215 separate fund, to be known as the Massachusetts Local and Regional Transportation Trust Fund,  
216 for the benefit of cities, towns, or districts that have accepted the provisions of this chapter and  
217 have imposed a tax surcharge on a tax collected by the commonwealth, subject to any  
218 exemptions adopted by a municipality or district. The fund shall consist of all revenues received  
219 by the commonwealth: (i) from the tax surcharge on such tax pursuant to section 3; (ii) from  
220 public and private sources as gifts, grants and donations to further local or regional transportation  
221 projects; and (iii) all other monies credited to or transferred to from any other fund or source  
222 pursuant to law.

223 (b) The state treasurer shall deposit revenues received by any such tax surcharge into the  
224 fund in accordance with section 9 in such manner as will secure the highest interest rate available  
225 consistent with the safety of the fund and with the requirement that all amounts on deposit be  
226 available for withdrawal without penalty for such withdrawal at any time. All interest accrued  
227 and earnings shall be deposited into the fund. The fund shall be administered in a manner to  
228 separately account for revenues raised by each city, town, or district, shall be held for the benefit  
229 of such city, town, or district, and expenditures from the fund shall be made solely for the  
230 administration and implementation of this chapter. Any unexpended balances shall be  
231 redeposited for future use by the city, town, or district consistent with this chapter.

232 (c) The state treasurer shall make all disbursements and expenditures from the fund  
233 without further appropriation, as directed by the commissioner of revenue in accordance with  
234 section 9. The department of revenue shall report by source all amounts credited to said fund and  
235 all expenditures from said fund. The commissioner of revenue shall assign personnel of the  
236 department as it may need to administer and manage the fund disbursements and any expense  
237 incurred by the department shall be deemed an operating and administrative expense of the  
238 program. The operating and administrative expenses shall not exceed 5 per cent of the annual  
239 total revenue deposited into the fund.

240 Section 9. (a) All sums received by the commissioner under this chapter shall, not less  
241 than quarterly, be distributed, credited and paid by the state treasurer upon certification of the  
242 commissioner to each city or town or the municipality treasurer or regional planning agency of  
243 the district and notified the commissioner of their acceptance.

244 (b) The state treasurer, upon certification of the commissioner, shall distribute the funds  
245 to the city or town, or the municipality treasurer or regional planning agency of the district based  
246 on the proportional amount the city, town or district has raised by imposing the surcharge. The  
247 total distribution of funds shall include all sources of revenue raised in the previous year as set  
248 forth in subsection (a) of section 8, less not more than 5 per cent of the annual total revenue of  
249 the fund, as set forth in subsection (c) of section 8. Any city, town or district seeking to dispute  
250 the commissioner's calculation of its distribution under this subsection shall notify the  
251 commissioner, in writing, not later than 1 year from the date the tax was distributed by the  
252 commissioner to the city, town or district.

253 (c) The commissioner shall be prohibited from diverting revenues derived from the tax  
254 surcharge into any other fund created by law.

255 (d) Notwithstanding any provision to the contrary, the commissioner may make available  
256 to cities, towns and districts any information necessary for administration of the tax surcharge  
257 imposed by this chapter including, but not limited to, a report of the amount of the surcharge on  
258 tax collected in the aggregate by each city, town or district under this chapter in the preceding  
259 fiscal year, and the identification of each individual vendor collecting the surcharge on sales tax  
260 collected under this chapter.

261 Section 10. (a) At any time after imposition of the tax surcharge, the governing body of  
262 each city or town may approve and the voters may accept an amendment to the amount and  
263 computation of the tax surcharge in the same manner and subject to the same requirements set  
264 forth in this chapter.

265 (b) At any time after imposition of the tax surcharge, a district under section 4, with the  
266 approval of the majority of voters in the district may accept an amendment to the amount and  
267 computation of the tax surcharge in the same manner and subject to the same requirements set  
268 forth in this chapter so that the surcharge becomes uniform in all municipalities of the district.

269 Section 11. The commissioner of revenue shall have the authority to promulgate rules and  
270 regulations to effect the purposes of this chapter.
