Resolve providing for the creation of a commemorative memorial portrait in the Massachusetts State House in honor of State Representative Doris Bunte.

1 **Resolved**, that the superintendent of the bureau of the state house shall, subject to the
2 approval of the art commission as to size and content, install and maintain a portrait in a suitable
3 space in the Massachusetts State House. In determining the location of such portrait, said
4 commission shall consult with the house committee on rules, the Massachusetts Black and Latino
5 Legislative Caucus, and shall cause said memorial to be officially installed in the Massachusetts
6 State House.
