**The Commonwealth of Massachusetts**

**In the Year Two Thousand Thirteen**

An Act authorizing the city of Springfield to exchange parcels of land.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Section 1. Notwithstanding any general or special law to the contrary, but subject to  
2 paragraphs (a), (b) and (g) of section 16 of chapter 30B of the General Laws, the city of  
3 Springfield ("city"), for the purposes of acquiring other land for parking for the Forest Park  
4 Middle School, may convey a certain parcel of land in Springfield owned by the City, upon such  
5 terms and conditions as the Mayor deems to be in the best interests of the City, to Glenshane I,  
6 LLC, or its successors and assigns then currently owning the apartment buidlings at 356-364  
7 Belmont Avenue, Springfield, MA. ("Glenshane") for use as a parking lot for the aparment  
8 buildings. The parcel to be conveyed is identified as "North Side Garfield Street", City Parcel #  
9 05520-0018, which is more particularly described on Exhibit #1 attached hereto, and which is  
10 identified as Parcel C on a Plan entitled "Plan of Land in Springfield, Massachusetts, Surveyed  
11 for the City of Springfield", dated December 16, 2011, which is on file with the Hampden  
12 Registry of Deeds at Book of Plans \_\_\_\_\_, page \_\_\_\_\_.

13 Section 2. Notwithstanding any general or special law to the contrary, as a condition of,  
14 and as consideration for, the conveyance authorized in Section 1. Glenshane shall transfer to the

15 City two parcels of land more particularly described as Parcel A and Parcel B on Exhibit #2 and  
16 identified as Parcel A and Parcel B on the Plan described in section 1, and such parcel shall be  
17 acquired and held for municipal purposes, under the jurisdiction of the School Department.

18 Section 3. The fair market value of the parcels to be conveyed by Glenshane to the City  
19 as described in Section 2 (Parcels A and B), shall be equal to or greater than the fair market value  
20 of the property to be conveyed by teh City to Glenshane as described in section 1 (Parcel C), as  
21 determined by an independent appraisal. For the purposes of the appraisal, the fair market value  
22 of the property shall be calculated in its highest and best use and, where applicable, as assembled  
23 with other lands owned or otherwise controlled by Glenshane. If there is a disparity in these  
24 values in favor of the City, then Glenshane shall, as a condition of the transfer, release teh City  
25 from any and all financial liability for the difference in value.

26 Section 4. This act shall take effect upon its passage.

28 Description of "Parcel C" - City owned " North Side Garfield Street" To be transferred  
29 to Glenshane

30 A certain parcel of land bounded and described as follows:

31 Beginning at bound at the intersection of the southerly sideline of Garfield Avenue and  
32 the westerly sideline of Oakland Street and running thence;

33 Northwesterly, on a curve to the left, having a radius of 9.87 feet, along land now or  
34 formerly of the City of Springfield, 15.67 feet to a point, thence;

35 S75-12'22"W along last named land, 216.26 feet to a point, thence;

36 N14-47'-38"W, along Garfield Avenue, 50.00 feet to a point, thence;

37 N75-12'-22"E, along Parcel B, land now or formerly of the City of Springfield, Parcel A  
38 and land now or formerly of the City of Springfield, 177.62 feet to a point, thence;

39 N09-23'-57"E, along last named land, 135.81 feet to a point, thence;

40 Southerly, on a curve to the right, having a radius of 30.00 feet, along the southerly  
41 sideline of Oakland Street, 14.13 feet to a point, thence;

42 S13-49'-27"E, last named land, 88.22 feet to a point, thence;

43 Southwesterly, on a curve to the right, having a radius of 22.00 feet, along last named  
44 land, 19.91 feet to a point, thence;

45 S14-47'-38"E, along last named land, 78.56 feet to a point, thence;

46           Containing an area of 14,952 square feet, more or less.

50           Parcel A

51           A certain parcel of land bounded and described as follows:

52           Beginning at an iron pipe at the southwest corner of land now or formerly of the City of  
53 Springfield, on a northerly sideline of Garfield Avenue, and running thence;

54           S75-12'-22"W along the northerly sideline of Garfield Avenue, 31.75 feet to a point,  
55 thence;

56           N14-47'-38"W, along land now or formerly of the City of Springfield, 69.45 feet to a  
57 point, thence;

58           N76-59'-01"E, along land now or formerly of Glenshane I, LLC, 24.78 feet to a point,  
59 thence;

60           S82-32'-37"W, along last named land, 29.14 feet to a point, thence;

61           S04-19'-55"W, along land now or formerly of the City of Springfield, 61.01 feet to a  
62 point of beginning

63           Containing an area of 2,838 square feet, more or less.

64           Parcel B

65           A certain parcel of land bounded and described as follows:

66           Beginning at an iron pipe at the southwest corner of land now or formerly of the City of  
67 Springfield, on the northerly sideline of Garfield Avenue, and running thence;

68           S75-12'-22"W along the northerly sideline of Garfield Avenue, 19.68 feet to a point,  
69 thence;

70           N14-47'-38"W, along land now or formerly of Glenshane I, LLC, 79.17 feet to a point,  
71 thence;

72           N76-59'-01"E, along last named land, 19.69 feet an iron pipe, thence;

73           S14-47'-38"E, along land now or formerly of the City of Springfield, 78.56 feet to a point  
74 of beginning

75           Containing an area of 1,552 square feet, more or less
