AN ACT TO ENSURE SAFE ROADS.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. Section 8 of chapter 90 of the General Laws, as appearing in the 2000
- 2 Official Edition, is hereby amended by inserting in line 11, after the word "require," the
- 3 following words:—
- 4 Nothing in this section shall permit the Registrar of Motor Vehicles to prohibit the issuance of a
- 5 driver's license or learner's permit based on a failure to provide Social Security No. or an
- 6 acceptable written denial notice immigration status, however the Registrar shall charge a
- 7 surcharge of \$300 if the applicant is unable to provide this documentation.
- 8 SECTION 2. Said section 8 of chapter 90 of the General Laws, as so appearing, is hereby
- 9 amended by inserting at the end of the first paragraph in line 21 the following new sentences:—
- Nothing in this section shall permit the Registrar of Motor Vehicles to prohibit the issuance of a
- driver's license or learner's permit based on a failure to provide Social Security No. or an
- 12 acceptable written denial notice immigration status; however the Registrar shall charge a
- surcharge of \$300 if the applicant is unable to provide this documentation.

- SECTION 4. Section 8B of chapter 90 of the General Laws, as appearing in the 2000 Official
- Edition, is hereby amended by inserting in line 7, after the word "require.", the following new
- 16 sentences:—
- Nothing in this section shall permit the Registrar of Motor Vehicles to prohibit the issuance of a
- driver's license or learner's permit based on a failure to provide Social Security No. or an
- 19 acceptable written denial notice immigration status; however the Registrar shall charge a
- surcharge of \$300 if the applicant is unable to provide this documentation.
