## The Commonwealth of Massachusetts

In the Year Two Thousand Eleven

An Act to strengthen the Massachusetts agricultural infrastructure relative to meat and poultry production and processing.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Section 118 of chapter 94 of the general laws, as appearing in the 2008 Official
- 2 Edition, is hereby amended by striking out the words "public health", in lines 13 and 17, and
- 3 inserting in place thereof, in each instance, the following words:- agricultural resources.
- 4 SECTION 2. Said section 118 of said chapter 94, as so appearing, is hereby further amended by
- 5 striking out the definition of "inspector" and inserting in place thereof the following definition:-
- 6 "Inspector", an employee or official of the department of agricultural resources, authorized by
- 7 the commissioner to perform any inspectional function.
- 8 SECTION 3. Section 120 of said chapter 94, as so appearing, is hereby amended by inserting
- 9 after the word "seven", in line 16, the following words:- provided, however that the
- 10 commissioner of administration shall set fees based on categories of sizes and types of facilities

- 11 as designated by the commissioner of agricultural resources, and that said fees are not
- 12 determined by either commissioner to be a significant financial burden.
- 13 SECTION 4. Section 124 of said chapter 94, as so appearing, is hereby amended by striking out,
- 14 in line 28, the words "director of the division of food and drugs" and inserting in place thereof
- 15 the following words:- commissioner of the department of public health or the commissioner's
- 16 designee.
- 17 SECTION 5. Section 125 of said chapter 94, as so appearing, is hereby amended by striking out,
- 18 in lines 8 and 10, the initials "D.P.H" and inserting in place thereof the initials:- D.A.R.
- 19 SECTION 6. Section 151 of chapter 111 of the general laws, as appearing in the 2008 Official
- 20 Edition, is hereby amended by inserting after the first sentence the following sentence:- This
- 21 section shall not apply to slaughter activities occurring on a farm operating consistent with
- 22 section 1A of chapter 128 where less than 50 mammals or 1,200 poultry are slaughtered
- 23 annually.
- 24 SECTION 7. Section 2 of chapter 128 of the general laws, as appearing in the 2008 Official
- 25 Edition, is hereby amended by adding the following subsection:-
- 26 (k) A state meat inspection program administered by the commissioner pursuant to section 116.
- 27 SECTION 8. Said chapter 128, as so appearing, is hereby amended by adding the following
- 28 section:-
- 29 Section 116. (a) Within the department of agricultural resources, there shall be state meat
- 30 inspection program administered by the commissioner. This program shall be responsible for all
- 31 slaughter, meat cutting, and meat packaging operations occurring in the commonwealth. The

- 32 goals of the program shall be to simultaneously protect public health, strengthen the local food
- 33 system, and promote economic development by ensuring a strong and diverse slaughter and
- processing infrastructure for the benefit of both farmers and consumers.
- 35 (b) The department may enter into cooperative agreements with the United States Department of
- 36 Agriculture and the United States Food and Drug Administration and to receive, hold and utilize
- 37 funding from these agencies for the purposes of this section.
- 38 SECTION 9. Within 18 months of the passage of this act the department of agricultural
- 39 resources shall promulgate regulations relative to the intent of this act including those for on-
- 40 farm and mobile slaughter operations. All regulations promulgated under the authority of this
- 41 act shall meet or exceed those of the federal agencies. Prior to the enactment of these
- 42 regulations, the department of public health shall continue to administer sections 118 to 131 of
- 43 chapter 94 as written prior to the passage of this act.
