Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 10 the words "amended by section 1 of chapter 85 of the acts of 2006" and inserting in place thereof
- 11 the following: "most recently amended by chapter 398 of the acts of 2008."
- 12 SECTION 5. Section 4 of said chapter 51 of the acts of 2010 is further amended by striking out
- 13 the word "third" in the first sentence and inserting in place thereof the word "fourth".
- 14 SECTION 6. Said chapter 51 of the acts of 2010 is hereby amended by striking out section 5 and
- 15 inserting in place thereof the following: "SECTION 5. The fifth paragraph of section 4 of said
- 16 chapter 317 of the acts of 1974, as amended by said chapter 398 of the acts of 2008, is hereby
- 17 amended by inserting before the first sentence of the paragraph the following sentence: "Except
- 18 as set forth herein with regard to taxi license sales, the following describes the appeal procedures
- 19 applicable to any board action."
- 20 SECTION 7. This act shall take effect upon its passage.
