Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Notwithstanding section 33B of chapter 44 of the General Laws or any other
- 2 general or special law, rule or regulation to the contrary, the city council of the city of Medford
- 3 may, by majority vote, on recommendation of the mayor, transfer within the last 2 months of
- 4 fiscal year 2011, or during the first 15 days of fiscal year 2012 to apply to the previous fiscal
- 5 year, an amount appropriated for the use of any department other than the school department to
- 6 the appropriation for any other department.
- 7 SECTION 2. Notwithstanding section 53F ½ of chapter 44 of the General Laws or any other
- 8 general or special law, rule or regulation to the contrary, the city of Medford may transfer not
- 9 more than \$1,224,000.000 from the Water Enterprise Fund or any separate reserve fund

- 10 containing a surplus produced from the Water Enterprise Fund to the city's general fund and the
- 11 city shall apply such sum of money for the fiscal year 2011 operating budget with no further
- 12 action by the city.
- 13 SECTION 3. The city of Medford shall reimburse the Water Enterprise fund in the amount of
- 14 \$1,224,000.00 no later than June 30, 2021.
- 15 SECTION 4. This act shall take effect upon its passage.
