## The Commonwealth of Massachusetts

In the Year Two Thousand Thirteen

An Act authorizing the town of Avon to establish a department of public works.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Notwithstanding the provisions of any general or special law to the
- 2 contrary, the board of selectmen of the town of Avon may merge the highway and water
- 3 departments of said town into a department of public works. The board of selectmen may
- 4 appoint a licensed engineer, or person of similar professional training, under contract to the town
- 5 to serve as the administrator of the department. The department of public works shall assume all
- 6 duties conferred upon the highway and water departments pursuant to any general or special law
- 7 or local by-law.
- 8 SECTION 2. Section 3 of chapter 236 of the acts of 1889 is hereby amended by striking
- 9 out the words "water commissioners hereinafter provided for" and inserting in place thereof the
- 10 following:- administrator of the department of public works.
- SECTION 3. Section 5 of said chapter 236 is hereby amended by striking out the words
- 12 "water commissioners hereinafter provided for" and inserting in place thereof the following:
- 13 administrator of the department of public works.
- SECTION 4. Said chapter 236 is hereby further amended by striking out section 10 and
- 15 inserting in place thereof the following:-
- Section 10. All the authority granted to the said town by this act, and not otherwise
- 17 specifically provided for, shall be vested in the department of public works, who shall be subject
- 18 to such instructions, rules and regulations as said town may impose by its vote.
