Eldridge (by vote of the town) that the town of Southborough be authorized to grant an additional license for the sale of all alcoholic beverages not to be drunk on the premises. The Commonwealth of Massachusetts

In the One Hundred and Eighty-Ninth General Court (2015-2016)

An Act authorizing the town of Southborough to grant an additional license for the sale of all alcoholic beverages not to be drunk on the premises.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Notwithstanding section 17 of chapter 138 of the General Laws, the
- 2 licensing authority of the town of Southborough may grant an additional license for the sale of
- 3 all alcoholic beverages not to be drunk on the premises pursuant to section 15 of said chapter 138
- 4 to Southborough Variety Corp. d/b/a Stony Brook Market, located at 162 Cordaville road. The
- 5 license shall be subject to all of said chapter 138, except said section 17.
- 6 SECTION 2. Upon the issuance of the license authorized by this act, Southborough
- 7 Variety Corp. shall surrender to the licensing authority the license currently held for the sale of
- 8 wines and malt beverages not to be drunk on the premises.
- 9 SECTION 3. The licensing authority shall not approve the transfer of the license to any
- 10 other location, but it may grant the license to a new applicant at the same location if the applicant

- 11 files with the licensing authority a letter from the department of revenue, indicating that the
- 12 license is in good standing with the department and that all applicable taxes have been paid.
- SECTION 4. If the license issued pursuant to this act is cancelled, revoked or no longer
- 14 in use, it shall be physically returned with all legal rights, privileges and restrictions pertaining
- 15 thereto, to the licensing authority, which may then grant the license to a new applicant at the
- 16 same location and under the same conditions as specified in this act.
- 17 SECTION 5. This act shall take effect upon its passage.
