An Act authorizing a ballot question in the town of Arlington relative to the granting of licenses for the sale of wines and malt beverages to be drunk on the premises in theaters.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Notwithstanding section 11 of chapter 138 of the General Laws, chapter 276 of the
- 2 acts of 1993 or any other general or special law to the contrary, the board of selectmen of the
- 3 town of Arlington shall cause to be placed on the official ballot at the 2012 annual town election
- 4 the following question:
- 5 "Shall the board of selectmen of the town be authorized to grant licenses for the sale of wines
- 6 and malt beverages to be drunk on the premises in theaters with a seating capacity of at least
- 7 100?"

9 SECTION 2. If a majority of votes cast in answer to the question is in the affirmative, the town 10 of Arlington shall be taken to have authorized the granting of licenses for the sale of wines and 11 malt beverages to be drunk on the premises in privately operated enclosed entertainment 12 facilities with minimum seating capacity of 100 that are used primarily for the presentation of 13 motion pictures or dramatic, comedic or musical performances, under the same terms and 14 conditions as such licenses currently authorized for the sale of wines and malt beverages to be 15 drunk on the premises in restaurants and subject to all other provisions of chapter 138.

16 SECTION 3. This act shall take effect upon its passage.
