Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- Chapter 112 of the General Laws, as appearing in the 2010 Official Edition, is hereby amended by inserting after section 84C the following section:-
- 3 Section 84D. Every licensed funeral director, or his or her agent or servant, before an
- 4 agreement as to the price of the merchandise and service is made, shall make available to all
- 5 potential clients information regarding funeral and burial benefits for veterans as set forth in
- 6 section 7 and 8 of chapter 115 and shall give or cause to be given to a client, a written statement
- 7 verifying that the funeral director, or his or her agent or servant, make such information available
- 8 to the potential client. The written statement shall be signed by the funeral director, or his or her

- agent or servant, and the potential client before an agreement as to the price of the merchandise
 and service is made.
- 11 Any funeral director who fails to comply with this section shall be punished by a fine of 12 not more than \$1,000.
