By Mr. Golden of Lowell, a petition (accompanied by bill, House, No. 3950) of Thomas A. Golden, Jr., and others (with the approval of the city council) relative to voting options for the city of Lowell for the 2021 municipal elections. Election Laws. [Local Approval Received.]

**The Commonwealth of Massachusetts**

**In the One Hundred and Ninety-Second General Court  
(2021-2022)**

An Act relative to voting options for the city of Lowell for the 2021 municipal elections.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. (a) Notwithstanding section 25B of chapter 54 of the General Laws or any  
2 other general or special law or any municipal ordinance to the contrary, any eligible voter may  
3 vote early by mail for any municipal election held on or after September 1, 2021 and before  
4 November 30, 2021 in the City of Lowell.

5           (b) Any qualified voter wanting to early vote by mail may file with the City of Lowell  
6 Elections and Census Office an application for an early voting ballot. Any form of written  
7 communication evidencing a desire to have an early voting ballot be sent for use for voting at an  
8 election shall be given the same effect as an application made in the form prescribed by the state  
9 secretary. The Elections and Census Office shall send early voting by mail ballots to those who  
10 have applied as soon as ballots are available. No application shall be deemed to be seasonably  
11 filed unless it is received in the Elections and Census Office before 5 p.m. on the fourth business  
12 day preceding the election.

13 (c) The Elections and Census Office may substitute absentee ballots for early voting  
14 ballots for those voters requesting to vote early by mail in municipal elections. An early voting  
15 ballot or absentee ballot substituted for an early voting ballot, along with an envelope bearing an  
16 affidavit as set forth in section 25B of chapter 54 of the General Laws, shall be provided to each  
17 qualified voter who participates in early voting by mail.

18 (d) The Elections and Census Office shall cause to be placed on the voting lists opposite  
19 the name of a qualified voter who participates in early voting the letters “EV” designating an  
20 early voter.

21 (e) The counting of early voting ballots shall be consistent with section 25B of chapter 54  
22 of the General Laws and regulations promulgated by the state secretary and appearing at 950  
23 CMR 47.00, as applicable. All envelopes referred to in this section shall be retained with the  
24 ballots cast at the election and shall be preserved and destroyed in the manner provided by law  
25 for the retention, preservation or destruction of official ballots.

26 (f) All early voting ballots voted by mail shall be received by the Elections and Census  
27 Office before the hour fixed for closing the polls on the date on which the municipal election is  
28 held. Early voting ballots cast under the authority of this section shall be processed at the polls in  
29 a manner consistent with that set forth in said section 25B of said chapter 54.

30 SECTION 2. For any municipal election held on or after September 1, 2021, and before  
31 November 30, 2021 in the city of Lowell, any person taking precaution related to COVID-19, or  
32 from guidance from a medical professional, local or state health official, or any civil authority  
33 shall be deemed to be unable by reason of physical disability to cast their vote in person at a  
34 polling location.

35           SECTION 3. Notwithstanding section 24 of chapter 54 of the General Laws or any other  
36 general or special law or any municipal ordinance to the contrary, the City of Lowell Election  
37 Commission may, by recorded and public vote, change any polling place to be used at any  
38 municipal election held on or after September 1, 2021 and before November 30, 2021, at least 20  
39 days prior to the date of the election. For the 2021 municipal preliminary and election, the City  
40 of Lowell Election Commission may designate one polling place per district. The Lowell  
41 Election Commission shall post on the municipal website and at other such places as it may  
42 determine, a description of the polling places and shall notify each household containing one or  
43 more registered voters of their district designation and corresponding polling place for the 2021  
44 elections.

45           SECTION 4. (a) Notwithstanding section 25B of chapter 54 of the General Laws or any  
46 other general or special law or municipal ordinance to the contrary, any eligible voter may vote  
47 early in-person for any special municipal election held on or after September 1, 2021 and before  
48 November 30, 2021 in the city of Lowell.

49           (b) The Lowell Election Commission shall vote to set the dates, hours and locations for  
50 early voting in person at least fourteen days prior to the proposed beginning of early voting. The  
51 early voting period may begin no sooner than 10 days before the election and end no later than  
52 the business day preceding the business day before the election.

53           (c) The Election Commission shall establish at least one early voting site that is centrally  
54 located, suitable and in a convenient public building and may set additional locations. Notice of  
55 the early voting location, dates and hours will be posted 48 weekday hours before the early  
56 voting period begins.

57 (e) A qualified voter voting early in person shall be provided with a ballot and an  
58 envelope where the ballot is placed after voting which contains an affidavit of compliance to be  
59 filled out by the voter. A qualified voter voting early in person shall complete an affidavit under  
60 the regulations promulgated by the state secretary for the administration of early voting and  
61 appearing at 950 CMR 47.00, as applicable, which shall include a notice of penalties under  
62 section 26 of chapter 56 of the General Laws.

63 SECTION 5. In submitting this legislation, the City of Lowell authorizes the City  
64 Manager to create and provide to the General Court and state agencies any and all additional  
65 information that may be necessary for passage; and

66 SECTION 6. In submitting this legislation, the City of Lowell authorizes the General  
67 Court to make such changes in the drafting process as are necessary for passage; and

68 SECTION 7. This act shall take effect upon its passage.
