## The Commonwealth of Massachusetts

In the Year Two Thousand Eleven

An Act to improve access to the services of educational psychologists.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 41 SECTION 6. This act shall apply to all policies, contracts, agreements, plans and certificates of
- 42 insurance issued or delivered within or without the commonwealth on or after March 1, 2006,
- 43 and to all policies, contracts, agreements, plans and certificates of insurance in effect before that
- 44 date upon renewal or after March 1, 2006.
