An Act amending the act establishing a charter for the town of Wrentham.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Section 1.3 of article I of the Wrentham home rule charter, as appearing in  
2 section 1 of chapter 116 of the acts of 2014, is hereby amended by striking out subsection (c) and  
3 inserting in place thereof the following subsection:-

4           (c) “Select board”, the duly elected select board for the town of Wrentham.

5           SECTION 2. Subsection (bb) of said section 1.3 of said article I of said charter, as so  
6 appearing, is hereby amended by striking out the words “board of selectmen” and inserting in  
7 place thereof the following words:- select board.

8           SECTION 3. Section 1.5 of said article I of said charter, as so appearing, is hereby  
9 amended by striking out the words “board of selectmen” and inserting in place thereof the  
10 following words:- select board.

11 SECTION 4. Section 2.3 of article II of said charter, as so appearing, is hereby amended  
12 by striking out the words “board of selectmen” and inserting in place thereof the following  
13 words:- select board.

14 SECTION 5. Section 2.5 of said article II of said charter, as so appearing, is hereby  
15 amended by striking out the words “board of selectmen” and inserting in place thereof the

72 appearing, is hereby amended by striking out the words “board of selectmen”, each time they  
73 appear, and inserting in place thereof, in each instance, the following words:- select board.

75           SECTION 25. Section 7.3 of article VII of said charter, as so appearing, is hereby  
76 amended by striking out the words “board of selectmen” and inserting in place thereof the  
77 following words:- select board.

78           SECTION 26. Section 7.4 of said article VII of said charter, as so appearing, is hereby  
79 amended by striking out the words “board of selectmen” and inserting in place thereof the  
80 following words:- select board.

81           SECTION 27. This act shall take effect upon its passage.
