The Commonwealth of Massachusetts

**In the One Hundred and Ninety-First General Court
(2019-2020)**

An Act relative to the disability retirement of Ryan Moore and Donald Demiranda, police officers in the town of Falmouth.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. (a) Notwithstanding any general or special law to the contrary and in order
2 to promote the public good, the Falmouth Retirement Board shall retire Ryan Moore, a police
3 officer in the Falmouth Police Department, who was injured in the line of duty and, as a result, is
4 permanently incapacitated from performing the essential duties of a police officer. The
5 retirement benefits shall be paid and administered in accordance with section 7 of chapter 32 of
6 the General Laws. Upon retirement, Ryan Moore shall receive a lump sum payment from the
7 Falmouth Retirement Board equal to his total accumulated retirement deductions.

8 (b) The annual amount of pension payable to Ryan Moore shall be equal to the regular
9 rate of compensation which would have been payable to him had he continued in service as a
10 police officer at the grade held by him at the time of his retirement. The payments shall continue
11 until his death or until he reaches age 65, whichever first occurs. The retirement shall become
12 effective commencing on the date immediately following the final day for which Ryan Moore
13 received regular compensation for such employment. The additional benefits granted in this act

14 shall be funded and administered by the Falmouth Retirement Board, consistent with and subject
15 to said chapter 32. All amounts paid under this act shall be nontaxable to the extent allowable
16 under state law.

17 (c) Upon attaining age 65, Ryan Moore shall receive a pension pursuant to section 7 of
18 said chapter 32, the yearly amount of which shall be equal to 80 per cent of the average annual
19 amount of pension paid to him in the previous 12 months.

20 (d) If Ryan Moore shall be married at the time of his retirement, then, upon his death,
21 said retirement board shall pay his surviving spouse if then living, a pension, payable in monthly
22 installments in the amount of 75 per cent of the annualized amount of the pension payable to
23 Ryan Moore on the date of his death. The pension shall be subject to section 103 of said chapter
24 32.

25 (e) Ryan Moore shall be indemnified by the town of Falmouth for hospital, medical and
26 other healthcare expenses related to treatment of injuries sustained while in the line of duty on
27 July 27, 2018, not otherwise covered by health insurance.

28 SECTION 2. (a) Notwithstanding any general or special law to the contrary and in order
29 to promote the public good, the Falmouth Retirement Board shall retire Donald Demiranda, a
30 police officer in the Falmouth Police Department, who was injured in the line of duty and, as a
31 result, is permanently incapacitated from performing the essential duties of a police officer. The
32 retirement benefits shall be paid and administered in accordance with section 7 of chapter 32 of
33 the General Laws. Upon retirement, Donald Demiranda shall receive a lump sum payment from
34 the Falmouth Retirement Board equal to his total accumulated retirement deductions.

35 (b) The annual amount of pension payable to Donald Demiranda shall be equal to the
36 regular rate of compensation which would have been payable to him had he continued in service
37 as a police officer at the grade held by him at the time of his retirement. The payments shall
38 continue until his death or until he reaches age 65, whichever first occurs. The retirement shall
39 become effective commencing on the date immediately following the final day for which Donald
40 Demiranda received regular compensation for such employment. The additional benefits granted
41 in this act shall be funded and administered by the Falmouth Retirement Board, consistent with
42 and subject to said chapter 32, except that sections 8 and 91A of said chapter 32 shall not apply.
43 All amounts paid under this act shall be nontaxable to the extent allowable under state law.

44 (c) Upon attaining age 65, Donald Demiranda shall receive a pension pursuant to section
45 7 of said chapter 32, the yearly amount of which shall be equal to 80 per cent of the average
46 annual amount of pension paid to him in the previous 12 months.

47 (d) If Donald Demiranda shall be married at the time of his retirement, then, upon his
48 death, said retirement board shall pay his surviving spouse if then living, a pension, payable in
49 monthly installments in the amount of 75 per cent of the annualized amount of the pension
50 payable to Donald Demiranda on the date of his death. The pension shall be subject to section
51 103 of said chapter 32.

52 (e) Donald Demiranda shall be indemnified by the town of Falmouth for hospital,
53 medical and other healthcare expenses related to treatment of injuries sustained while in the line
54 of duty on July 27, 2018, not otherwise covered by health insurance.

55 SECTION 3. This act shall take effect upon its passage.
