The Commonwealth of Massachusetts

**In the One Hundred and Ninety-Second General Court
(2021-2022)**

An Act making appropriations for the fiscal year 2021 to provide for supplementing certain existing appropriations and for certain other activities and projects.

Whereas, The deferred operation of this act would tend to defeat its purposes, which are forthwith to make supplemental appropriations for fiscal year 2021 and to make certain changes in law, each of which is immediately necessary to carry out those appropriations or to accomplish other important public purposes, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. To provide for supplementing certain items in the general appropriation act
2 and other appropriation acts for fiscal year 2021, the sums set forth in section 2 are hereby
3 appropriated from the General Fund unless specifically designated otherwise in this act or in
4 those appropriation acts, for the several purposes and subject to the conditions specified in this
5 act or in those appropriation acts, and subject to the laws regulating the disbursement of public
6 funds for the fiscal year ending June 30, 2021. These sums shall be in addition to any amounts
7 previously appropriated and made available for the purposes of those items. These sums shall be
8 made available until June 30, 2022.

310 pursuant to this section shall be made from the positive undesignated fund balances in the
311 budgetary funds. Before certifying the consolidated net surplus under this section, the
312 comptroller shall, to the extent possible, eliminate deficits in any fund contributing to the surplus

314 Expenditures from the Transitional Escrow Fund shall be subject to appropriation. The Fund
315 shall not be subject to section 5C of chapter 29 of the General Laws.

316 (b) The Transitional Escrow Fund shall expire on June 30, 2022, at which time the
317 comptroller shall transfer the unexpended balance in it to the Commonwealth Stabilization Fund
318 established in section 2H of chapter 29 of the General Laws.

319 SECTION 17. Notwithstanding any general or special law to the contrary, the special
320 commission established in section 101 of chapter 41 of the acts of 2019, as amended by section
321 77 of chapter 124 of the acts of 2020, is hereby revived and continued to January 31, 2022. The
322 special commission shall file its report pursuant to said section 101 of said chapter 41 with the
323 clerks of the house of representatives and the senate, the house and senate committees on ways
324 and means and the joint committee on public safety and homeland security not later than January
325 31, 2022.

326 SECTION 18. Notwithstanding any general or special law to the contrary, the special
327 commission established in section 105 of chapter 227 of the acts of 2020 is hereby revived and

328 continued to December 31, 2021. The special commission shall file its report pursuant to said
329 section 105 of said chapter 227 with the clerks of the house of representatives and the senate not
330 later than December 31, 2021.

331 SECTION 19. Notwithstanding any general or special law to the contrary, the special
332 legislative commission established in section 107 of chapter 253 of the acts of 2020 is hereby
333 revived and continued to March 30, 2022. The special legislative commission shall file its report
334 pursuant to subsection (h) of said section 107 of said chapter 253 with the governor, the speaker
335 of the house of representatives and the president of the senate and the clerks of the house of
336 representatives and senate not later than March 30, 2022.

337 SECTION 20. Notwithstanding any general or special law to the contrary, the special

339 revived and continued to December 31, 2021. The special legislative commission shall file its
340 report pursuant to subsection (d) of said section 110 of said chapter 253 with the clerks of the
341 house of representatives and the senate not later than December 31, 2021.

342 SECTION 21. Notwithstanding any general or special law to the contrary, the special
343 legislative commission established in section 112 of chapter 253 of the acts of 2020 is hereby
344 revived and continued to December 31, 2021. The special legislative commission shall file its
345 report pursuant to subsection (d) of said section 112 of said chapter 253 with the clerks of the
346 house of representatives and the senate not later than December 31, 2021.

347 SECTION 22. Notwithstanding any general or special law to the contrary, the special
348 legislative commission established in section 116 of chapter 253 of the acts of 2020 is hereby
349 revived and continued to December 31, 2021. The special legislative commission shall file its

350 report pursuant to subsection (c) of said section 116 of said chapter 253 with the clerks of the
351 house of representatives and the senate not later than December 31, 2021.
