An Act Relative to Controlled Substances..

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Subsection (a) of Class B of Section 31 of Chapter 94C of the General Laws, as  
2 appearing in the 2008 Official Edition, is hereby amended by inserting the following new  
3 subdivision:

4 (9) Kratom (*Mitragyna speciosa*), or any salt, compound, derivative, or preparation of kratom,  
5 and any salt, compound, derivative, or preparation thereof which is chemically equivalent or  
6 identical with kratom

7 SECTION 2. Subsection (e) of Class C of Section 31 of Chapter 94C of the General Laws, as  
8 appearing in the 2008 Official Edition, is hereby amended by inserting the following items:

9 (17) Salvia Divinorum

10 (18) Salvinorin A

11 (19) Catha Edulis

12 SECTION 3. Section 1 of Chapter 94C of the General Laws, as appearing in the 2008 Official

13 Edition, shall be amended by adding, at the end of clause 12, the following subsection:

14 (p) blunt wrappers

15 (q) rose bud smoking pipes
