Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. Section 178C of chapter 6 of the General Laws, as appearing in the 2022
 Official Edition, is hereby amended by inserting, in line 62, after the words "chapter 265;" the
 following words:- indecent assault and battery on vulnerable persons in custody by law
 enforcement under section 13H ½ of said chapter 265; indecent assault and battery on a patient
- SECTION 2. Said section 178C of said chapter 6, as so appearing, is hereby further
 amended by inserting, in line 67, after the words "chapter 265;" the following words: rape of a
 patient or client by a health care provider under section 22D of said chapter 265;.

SECTION 3. Section 1 of chapter 123A of the General Laws, as so appearing, is hereby amended by inserting, in line 49, after the word "sixty-five;" the following words:- indecent assault and battery on vulnerable persons in custody by law enforcement under section 13H ½ of said chapter 265; indecent assault and battery on a patient or client by a health care provider under section 13H ¾ of said chapter 265;.

SECTION 4. Said section 1 of said chapter 123A of the General Laws, as so appearing, is hereby further amended by inserting, in line 54, after the words "chapter 265;" the following words:- rape of a patient or client by a health care provider under section 22D of said chapter 265;.

SECTION 5. Section 133E of chapter 127 of the General Laws, as so appearing, is hereby amended by inserting, in line 16, after the words "chapter 265" the following words:-indecent assault and battery on vulnerable persons in custody by law enforcement under section 13H ½ of said chapter 265; indecent assault and battery on a patient or client by a health care provider under section 13H ¾ of said chapter 265;.

SECTION 6. Said section 133E of said chapter 127 of the General Laws, as so appearing, is hereby further amended by inserting, in line 20, after the words "chapter 265;" the following words:- rape of a patient or client by a health care provider under section 22D of said chapter 265;.

SECTION 7. Chapter 265 of the General Laws is hereby amended by inserting after Section 13H ½ the following section:-.

Section 13H ³/₄ (a) For the purposes of this section "health care provider" shall mean a person, corporation, facility or institution licensed by the commonwealth to provide health care of professional services as a physician, hospital, clinic or nursing home, dentist, registered or licensed nurse, optometrist, podiatrist, chiropractor, physical therapist, psychologist, social worker, or acupuncturist, or an officer, employee or agent thereof acting in the scope and course of their employment.

(b) A person who is, or holds themselves out to be, a health care provider or clergy member, and who commits an indecent assault and battery on a patient or client during the course of diagnosis, counseling, or treatment shall be punished by imprisonment in the state prison for not more than 5 years, or by imprisonment for not more than 2 1/2 years in a house of correction. In a prosecution commenced under this section, the patient or client shall be deemed incapable of consenting to contact of a sexual nature when consent was procured by a false representation that the act was for a legitimate medical or treatment purpose.

SECTION 8. Said Chapter 265 of the General Laws is hereby further amended by inserting after Section 22C the following section:-

Section 22D (a) For the purposes of this section "health care provider" shall mean a person, corporation, facility or institution licensed by the commonwealth to provide health care of professional services as a physician, hospital, clinic or nursing home, dentist, registered or licensed nurse, optometrist, podiatrist, chiropractor, physical therapist, psychologist, social worker, or acupuncturist, or an officer, employee or agent thereof acting in the scope and course of their employment.

(b) A person who is, or holds themselves out to be, a health care provider or clergy member, and who knowingly induces a patient or client to engage in sexual intercourse during the course of diagnosis, counseling, or treatment, shall be punished by imprisonment in the state prison for not more than 20 years. In a prosecution commenced under this section, the patient or client shall be deemed incapable of consenting to contact of a sexual nature when consent was procured by false representation that the act was for a legitimate medical or treatment purpose.
