An Act relative to used police cars sold at auction.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           Section 92A of chapter 266 of the General Laws, as appearing in the 2014 Official  
2 Edition, is hereby amended by striking out the words "by a fine of not less than ten nor more  
3 than five hundred dollars" and inserting in place thereof the following words:-

4           by a fine of not less than five hundred dollars for a first offense. Second and subsequent  
5 offenses shall carry a fine of not less than one thousand dollars.
