1           *Ordered,* That the committee on Cannabis Policy be authorized to sit during a recess of  
2 the General Court to make an investigation and study of House documents numbered 145, 147,  
3 148, 149, 152, 153, 154, 155, 156, 157, 159, 160, 161, 162, 163, 165, 167, 170, 176, 180 and  
4 4026, relative medical marijuana, taxes and other related matters.

5           Said committee shall report to the General Court the results of its investigation and study  
6 and its recommendations, if any, together with drafts of legislation necessary to carry such  
7 recommendations into effect, by filing the same with the Clerk of the House of Representatives  
8 on or before December 31, 2022.
