By Mr. Smola of Palmer and Senator Brewer, a joint petition (accompanied by bill, House, No. 574) of Todd M. Smola and Stephen Brewer relative to the town of Sturbridge conveying a certain parcel of land. [Local Approval Received.] [Municipalities and Regional Government].

An Act authorizing the town of Sturbridge to convey a certain parcel of land.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. The board of selectmen of the town of Sturbridge may transfer the care, custody
2 and control of a certain parcel of land owned by the town and held for educational purposes to
3 said board for the purpose of conveyance to an abutting property owner. The property is a certain
4 L-shaped portion of town-owned land located at 45 Burgess School road in the town of
5 Sturbridge and is described in an order of taking recorded with the Worcester south district
6 registry of deeds in book 4350 at page 324. The parcel, shown on a sketch entitled “Land Swap
7 Study” dated December 16, 2009 and on file in the office of the town clerk, contains 22,340
8 square feet, more or less, is no longer needed by the town for educational purposes or any other
9 public purposes and is surplus property. The parcel shall be conveyed subject to a drainage
10 easement for the benefit of the town of Sturbridge.

11 SECTION 2. The conveyance authorized in section 1 shall be on such terms and conditions, and
12 for such consideration, as the selectmen deem appropriate; provided, however, that in
13 consideration of the conveyance set forth in section 1, the grantees as abutters shall convey to the
14 board of selectmen of the town of Sturbridge a square-shaped parcel of land, approximately
15 11,157 square feet, lying to the north of their hotel at 408 Main street near the southwest corner
16 of land of the town of Sturbridge for the purpose of completing the Burgess Elementary School
17 project. The parcel is also shown on the sketch described in section 1 entitled “Land Swap
18 Study” on file in the office of the town clerk and is a portion of a 2.38 acre parcel identified in
19 the town of Sturbridge assessor database as ID# 415-02446-408.

20 SECTION 3. The board of selectmen of the town of Sturbridge and the grantees shall take all
21 actions they deem necessary or advisable in their sole discretion to carry out the conveyances
22 and the grant of the drainage easement as set forth in sections 1 and 2, including, without
23 limitation, the execution of any and all documents relative thereto.
