AN ACT EXEMPTING TOWNS FROM CERTAIN FEES.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Section 3B of chapter 21E of the General Laws, as appearing in the 2006 Official Edition, is
- 2 hereby amended, in line 30, by inserting after the word “excluding”, the following words:-
- 3 “counties, cities, towns and”
- 4 SECTION 2. Notwithstanding any general or special law to the contrary, the fees owed by counties,
- 5 cities, and towns prior to this act shall be waived.
