In the One Hundred and Eighty-Ninth General Court (2015-2016)

An Act to encourage quality reviews and reduce costs in health care.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 2 Chapter 111 of the General Laws, as appearing in the 2012 Official Edition, is hereby
- 3 amended by inserting at the end of section 204 the following:
- 4 (f) The provisions of this section shall apply to any committee formed by an individual
- 5 health care provider, physician group practice, licensed health care facility or any combination
- 6 thereof to perform the duties or functions of medical peer review as set forth in section one of
- 7 this chapter, notwithstanding the fact that the formation of the committee is not required by law
- 8 or regulation or that the individual, group or facility is not solely affiliated with a public hospital
- 9 or licensed hospital or nursing home or health maintenance organization.

- 11 Chapter 231: Section 60K of the General Laws as appearing in the 2012 Official Edition

- hereby amended by its deletion and replacement with the following:
- 14 Section 60K. In any action for malpractice, negligence, error, omission, mistake or unauthorized rendering of professional services against a provider of health care, in which a 15 verdict is rendered or a finding made or an order for judgment made for pecuniary damages for personal injuries to the plaintiff or for consequential damages, there shall be added by the clerk 17 18 of the court to the amount of damages interest thereon, at a rate to be determined as set forth below rather than the rate specified in section 6B of chapter 231, from the date of the 19 20 commencement of the action even though such interest brings the amount of the verdict or 21 finding beyond the maximum liability imposed by law. For all actions commenced after the effective date of this act, the rate of interest to be applied by the clerk shall be at a rate equal to the weekly average 1-year constant maturity Treasury yield plus 2 per cent, as published by the 24 Board of Governors of the Federal Reserve System for the calendar week preceding the date of judgment. At no point shall the rate of interest established by this section exceed the rate of interest set forth in said section 6B of chapter 231.

32	In any action for malpractice, negligence, error, omission, mistake or unauthorized

38	greater than 50%. In addition the plaintiff shall have the burden of proving the following:

40	specialty thereof, if any, that the defendant practices in the community in which he

42	in a similar community at the time the alleged injury or wrongful action occurred;
43	(2) That the defendant acted with less than or failed to act with ordinary and reasonable

46	(3) As a direct and proximate result of the defendant's negligent act or omission, the

49	(4) The plaintiff was a patient of the defendant and had a professional relationship to the

unless it expressly includes such damages.
