In the One Hundred and Eighty-Ninth General Court (2015-2016)

An Act promoting job training in the Commonwealth.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Section 14L of chapter 151A of the General Laws, as so appearing, as
- 2 amended by section 77 of chapter 144 of the acts of 2014, is hereby amended by striking in the
- 3 first sentence of subsection (a) the figure ".056" and inserting in place thereof ".112"
- 4 SECTION 2. Section 14L of chapter 151A of the General Laws, as so appearing, as
- 5 amended by section 77 of chapter 144 of the acts of 2014, is hereby amended by striking in the
- 6 second sentence of subsection (a) the figure "\$22,000,000 and inserting in place thereof
- 7 "\$44,000,000".
- 8 SECTION 3. Section 14L of chapter 151A of the General Laws, as so appearing, as
- 9 amended by section 77 of chapter 144 of the acts of 2014, is hereby amended in subsection (a)
- 10 by adding in the third sentence after the word "deposit" the words "50 percent of".

- SECTION 4. Section 14L of chapter 151A of the General Laws, as so appearing, as
- 12 amended by section 77 of chapter 144 of the acts of 2014, is hereby amended in subsection (a)
- 13 by adding to the end of the third sentence the following:
- 14 ", and shall deposit 50 per cent of the proceeds of said workforce training contributions in
- 15 the Workforce Competitiveness Trust Fund, established by Section 2WWW of chapter 29 of the
- 16 General Laws."
