**In the One Hundred and Ninety-Second General Court
(2021-2022)**

An Act relative to illegal drug and firearm trafficking.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Chapter 94C of the General Laws, as appearing in the 2018 Official Edition, shall be
2 amended by adding the following new section:-

3 Section 32O. Whoever is found guilty for trafficking substances under section 32E
4 paragraphs (c) or (c1/2) of this chapter and is concurrently or separately found guilty of any of
5 sections 10E, 10I, 10J, or 10K of chapter 269 regarding the trafficking or theft of firearms, rifles,
6 shotguns or machine guns shall be punished by a term of up to life imprisonment in the state
7 prison, that said sentence may include a fine of not more than \$500,000. A prosecution
8 commenced under this section shall not be placed on file or continued without a finding. A
9 person convicted of violating this section shall not be eligible for furlough, work release,
10 temporary release or receive any deduction from his sentence for good conduct under sections
11 129C or 129D of chapter 127.
