Whereas, the deferred operation of this act would tend to defeat its purpose, which is forthwith to [Emergency Preamble Text] convenience.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. The first paragraph of section 1 of chapter 53 of the acts of 1991 is hereby
- 2 amended by striking out the last sentence and inserting in place thereof the following sentence:-
