By Ms. Chandler, petition (accompanied by bill, Senate, No. 1078) of Lewis, Jehlen, Brownsberger and other members of the General Court for legislation to promote patient engagement in health care decisions [Joint Committee on Public Health].

The Commonwealth of Massachusetts

In the Year Two Thousand Eleven

An Act promoting patient engagement in health care decisions.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Chapter 111 of the General Laws is hereby amended by inserting after
2 section 222 the following section:—

3 Section 223.

4 (a) As used in this section, the following words shall have the following meanings:

5 “Shared decision-making,” a collaborative process between patient and clinician that
6 engages the patient in decision-making, provides patients with information about trade-offs
7 among treatment options, and facilitates the incorporation of patient preferences and values into
8 the medical plan.

9 “Patient decision aid,” an educational tool that helps patients understand and
10 communicate their beliefs and preferences related to their treatment options, and to decide with

11 their health care provider what treatments are best for them based on their treatment options,
12 scientific evidence, circumstances, beliefs and preferences.

13 (b) The department shall develop a plan for the optimal use of shared decision-making
14 tools and patient decision aids in Massachusetts in order to ensure patients make fully informed
15 decisions about medical care. The plan shall include a list of conditions, to be reviewed and
16 updated periodically by the Shared Decision-Making Advisory Committee, for which patient
17 decision aids shall be used. The plan shall recommend standards for appropriate use and content
18 of patient decision aids, based on the best available evidence and nationally-promulgated
19 standards. For surgical procedures, such information shall include, at a minimum, information on
20 survival rates, adverse effects, alternatives to surgery, percentage of patients needing the
21 procedure again, and cost.

22 (c) The department shall establish a Shared Decision-Making Advisory Committee to
23 assist in developing the plan, reviewing the list of conditions, evaluating outcomes, and
24 recommending changes. The Shared Decision-Making Advisory Committee shall include at least
25 one consumer representative. The department shall conduct an evaluation of the use of shared
26 decision-making tools and patient decision aids in Massachusetts on a regular basis, as
27 determined by the Advisory Committee.

28 (d) All insurers, including the MassHealth program established under chapter 118E and
29 the Commonwealth Care Health Insurance Program established under chapter 118H, shall
30 reimburse providers for the use of shared decision-making tools and patient decision aids.
