Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Section 174E of Chapter 140 of the General Laws, as appearing in the 2012 Official

- 2 Edition, is hereby amended by inserting at the end thereof the following:-
- 3 (h) In addition to animal control officers, this section may be enforced by Massachusetts
- 4 Society for the Prevention of Cruelty to Animals and Animal Rescue League of Boston officers
