An Act enhancing the issuance of citations for cruel conditions for animals.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. Section 174E of Chapter 140 of the General Laws as appearing in the 2016
- 2 Official Edition, is hereby amended by inserting after subsection (h) the following subsection:
- 3 (i) Subpart (f)(1) of this section shall also apply to farm animals, as defined in 9
- 4 C.F.R. § 1.1 (2016).
