An Act ensuring the safety of people with pets in disasters .

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Section 1 of chapter 639 of the acts of 1950 is hereby amended by inserting  
2 after the word “persons” the following words: – and household pets and service animals, as  
3 defined by the Federal Emergency Management Agency, pursuant to 42 U.S.C. § 1570b,

4 SECTION 2. Section 1 of chapter 639 of the acts of 1950 is hereby amended by inserting  
5 at the end of the second paragraph the following words: –

6 Any emergency plan of operations shall include strategies to support the needs of people  
7 with household pets, and the needs of household pets under their care, including service animals.  
8 Such local organization for civil defense shall take appropriate steps to educate the public  
9 regarding the resources available in the event of an emergency and the importance of emergency  
10 preparedness planning.
