An Act to enhance access to prescription information and overdose reporting for care coordination.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Section 24A of Chapter 94C of the general laws, as so appearing, is hereby  
2 amended by striking subsection (g) and inserting in place thereof the following:

3           (g) The department may, at its initiative, provide data from the prescription monitoring  
4 program to practitioners in accordance with section 24; provided, however, that healthcare  
5 providers, as defined in Section 1 of Chapter 111, shall be able to access the data directly  
6 through a secure electronic medical record, health information exchange, or other similar  
7 software or information systems connected to the prescription monitoring program for the  
8 purposes of: (i) improving ease of access and utilization of such data for treatment, diagnosis, or  
9 healthcare operations; (ii) supporting integration of such data within the electronic health records  
10 of a healthcare provider for purposes of treatment, diagnosis, or healthcare operations; or, (iii)  
11 allowing healthcare providers and their vendors to maintain such data for the purposes of

12 compiling and visualizing such data within the electronic health records of a healthcare provider  
13 that supports treatment, diagnosis, or healthcare operations.

14 SECTION 2. Section 1 of Chapter 55 of the Acts of 2015, as most recently amended by  
15 Section 136 of Chapter 133 of the Acts of 2016, is hereby further amended by striking out the  
16 first paragraph and inserting in place thereof the following paragraph:

17 Notwithstanding any general or special law to the contrary, the secretary of health and  
18 human services, in collaboration with the department of public health, shall conduct or provide  
19 for an examination of the prescribing and treatment history, including court-ordered treatment or  
20 treatment within the criminal justice system, of persons in the commonwealth who suffered fatal  
21 or nonfatal opiate overdoses in calendar years 2013 to 2020, inclusive. Any report or  
22 supplemental reports resulting from this examination shall provide any data in an aggregate and  
23 de-identified format.

24 SECTION 3. Section 1 of Chapter 55 of the Acts of 2015, as most recently amended by  
25 Section 137 of Chapter 133 of the Acts of 2016, is hereby further amended by striking out the  
26 fourth paragraph and inserting in place thereof the following paragraph:

27 The report, which shall be publicly available, shall be filed with the clerks of the senate  
28 and house of representatives, the house and senate chairs of the joint committee on mental health  
29 and substance abuse, the joint committee on public health, the joint committee on health care  
30 financing and the house and senate committees on ways and means. The secretary of health and  
31 human services may publish supplemental reports on the trends identified through its  
32 examination; provided, however, that any supplemental report shall be filed not later than July 1,  
33 2021 and shall be filed with the clerks of the senate and house of representatives, the house and

34 senate chairs of the joint committee on mental health and substance abuse, the joint committee  
35 on public health, the joint committee on health care financing and the house and senate  
36 committees on ways and means.
