### The Commonwealth of Massachusetts

In the One Hundred and Ninetieth General Court (2017-2018)

An Act improving treatment for Alzheimer's and dementia.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. Section 2 of chapter 112 of the General Laws, as appearing in the 2014
- 2 Official Edition, is hereby amended by adding the following paragraph:-
- The board shall require that any continuing education necessary for the renewal of a
- 4 physician's certificate of registration shall include a course of training and education on the
- 5 diagnosis, treatment, and care of patients with cognitive impairments, including, but not limited
- 6 to, Alzheimer's disease and dementia.
