## The Commonwealth of Massachusetts

In the One Hundred and Eighty-Ninth General Court (2015-2016)

Resolve establishing a special commission on prisoner and correctional officer suicides.

1 Resolved, SECTION 1. There shall be a special commission to study the prevention of 2 suicide amongst prisoners and correctional officers in Massachusetts correctional facilities. The commission shall consist of the secretary of the executive office of public safety or the 3 secretary's designee who shall serve as chair; the commissioner of the department of correction 4 or the commissioner's designee; the commissioner of the department of mental health or the 5 commissioner's designee; one person to be appointed by the president of the senate; one person 6 to be appointed by the speaker of the house of representatives; five persons to be appointed by 7 the governor, one of whom shall be a representative of a legal advocacy organization that has 8 expertise with issues related to prisons and prisoners, one of whom shall be a representative of a 9 community organization or public agency that works with prisoners and their families, one of 10 whom shall be a representative of an organization that specializes in suicide prevention, one of 11 whom shall be a representative of an organization that represents Massachusetts corrections 12

13 officers, and one of whom shall be a representative of an organization that represents

14 Massachusetts sheriffs. Each member shall serve without compensation.

15 The commission shall review the state of suicide prevention programs in Massachusetts' correctional facilities and develop model plans, recommend program changes, highlight budget 16 priorities and recommend best practices that could be utilized to reduce instances of prisoner and 17 correctional officer suicide, and attempted suicide. The commission shall: (1) examine and 18 evaluate the state of jail and prison suicide prevention policies in the commonwealth; (2) 19 20 examine and evaluate suicide prevention training for correctional facility staff personnel in the commonwealth; (3) develop recommendations on ways in which correctional facilities can 21 22 improve intake screening and bookkeeping; (4) examine and develop recommendations on methods by which correctional facilities may improve identification, referral, and evaluation of 23 24 individual suicide risk; (5) provide recommendations for improving communication between 25 detention facility staff and arresting and/or transporting officers, as well as between detention facility staff and potentially suicidal inmates; (6) examine and develop recommendations on 26 methods by which correctional facilities may improve housing designated for inmates identified 27 as suicidal; (7) provide recommendations for improving observation and treatment plans for 28 inmates identified as suicidal; (8) provide recommendations for improving suicide intervention; 29 30 and (9) examine and develop recommendations for how correctional facilities may improve or 31 establish practices of postmortem notification, reporting, and mortality-morbidity reviewing. (10) develop recommendations for the provision of mental health counseling services to corrections 32 33 officers that have a need for such services. (11) examine ways in which correctional facilities can reduce stress, anxiety, and depression among corrections officers. (12) examine training 34

35 programs for incoming corrections officers and develop recommendations for programs to36 include a discussion of mental preparedness.

37 The commission may hold public hearings to assist in the collection and evaluation of38 data and testimony.

The commission shall submit its findings and recommendations relative to suicide prevention, together with drafts of legislation necessary to carry those recommendations into effect, by filing the same with the clerks of the house of representatives and senate, the house and senate committees on ways and means, the joint committee on public safety and homeland security, and the joint committee on mental health and substance abuse not later than March 31, 2017.
