By Mr. Cyr, a petition (accompanied by bill, Senate, No. 1273) of Julian Cyr, Mathew J. Muratore, Angelo J. Puppolo, Jr., Jason M. Lewis and other members of the General Court for legislation relative to the safe care of residents with active substance use disorder accessing skilled nursing facility care. Mental Health, Substance Use and Recovery.

The Commonwealth of Massachusetts

**In the One Hundred and Ninety-Second General Court
(2021-2022)**

An Act relative to the safe care of residents with active substance use disorder accessing skilled nursing facility care.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Chapter 111 of the General Laws, as appearing in the 2018 Official Edition, is hereby
2 amended by inserting the following new sections after Section 71C:-

3 Section 71D: Minimum Safety and Quality of Service standards for Substance Use
4 Disorder Units.

5 (a) Notwithstanding any general or special law to the contrary, the department, in
6 consultation with the post-acute care substance use disorder council, shall establish criteria for
7 special care units in long term care facilities for the purpose of meeting the care needs of patients
8 with active substance use disorder requiring post-acute care in long term care facilities. Nothing
9 in this legislation shall require a long-term care facility to establish a substance use disorder
10 special care unit in order to provide care to patients with active substance use disorder requiring
11 post-acute care or require long term care facilities to provide a substance use treatment program.

12 (b) In order to meet the care needs and safety of all patients residing in a long term care
13 facility in establishing the criteria for special care units for substance use disorder, the
14 department, in consultation with the council, shall establish and make recommendations that are
15 evidenced-based in the following areas including, but not be limited to: counseling; assessment;
16 visitation; room searches; medication maintenance therapy; staff training; and discharge
17 planning. Provided further that the department, in consultation with the council, shall develop a
18 resource guide for the purpose of assisting long term care facilities in accessing counseling
19 services for patients and promoting a safe discharge of patients with active substance use
20 disorder.

21 (c) All criteria or regulatory proposals in connection with the establishment of substance
22 use disorder special care units shall take into consideration the fiscal impact on long term care
23 facilities that will establish such a unit. Provided further that the department in coordination with
24 the council shall issue a recommendation to MassHealth on funding a special Medicaid nursing
25 facility substance use disorder rate add-on.

26 (d) The Department shall seek any waivers necessary to implement said regulations or
27 criteria from the Centers for Medicare and Medicaid Services to ensure the care and safety of
28 patients in long term care facilities in the Commonwealth.

29 (e) The Department shall provide quarterly updates on the establishment of criteria for
30 substance use disorder special care units for the purpose of meeting the care needs of patients
31 with active substance use disorder to the house and senate committees on ways and means, the
32 joint committee on public health, the joint committee on elder affairs and the joint committee on
33 mental health and substance use and recovery.

34 (f) The Department shall promulgate the resource guide for the purpose of assisting long
35 term care facilities in accessing counseling services for patients and promoting a safe discharge
36 of patients with active substance use disorder and its initial criteria to implement section 71D of
37 chapter 111 of the General Laws not later than April 1, 2022.

38 Section 71D½: Post-Acute Care Substance Use Disorder Council

39 Notwithstanding any general or special law to the contrary, there is hereby established
40 within the department a post-acute care substance use disorder council for the purpose of making
41 recommendations to the department on criteria for substance use disorder special care units in
42 long term care facilities. The council shall be made up of at least sixteen members and shall be
43 comprised of the following: (i) the commissioner of public health or a designee; (ii) the
44 undersecretary of MassHealth or a designee; (iii) the state long-term care ombudsman or a
45 designee; (iv) the executive director of the health policy commission or a designee; (v) a member
46 of the public health council; (vi) a member appointed by the Massachusetts Senior Care
47 Association, (vii) a member appointed by the Leading Age; (viii) a member appointed by the
48 Association of Behavior Healthcare; (ix),a member appointed by Massachusetts Health and
49 Hospital Association; (x) a MassHealth certified accountable care organization behavioral health
50 community partner; (xi) an addiction medicine specialist appointed by the Massachusetts
51 Medical Society; (xii) the medical director of a long term care facility; (xiii) a direct care worker
52 of a long term care facility; (xiv) a long term care facility consumer; (xv) a provider from the
53 addiction recovery community; and (xvi) a patient from the addiction recovery community.
