An Act regulating the closure of state police barracks.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Chapter 6A of the General Laws is hereby amended by inserting after Section 18 <sup>3</sup>/<sub>4</sub> the  
2 following section:-

3 Section 18 <sup>7</sup>/<sub>8</sub>. (a) The secretary of public safety and security shall provide written notice  
4 to the clerks of the senate and house of representatives of a proposed closure of a state police  
5 barracks not less than 120 days prior to the closure. The executive office of public safety and  
6 security shall conduct public hearings which shall be held in not less than 2 impacted  
7 communities before a closure and shall prepare a report which shall include, but not be limited  
8 to:

9 (i) an examination of the public safety impact that the closing of a barracks would have  
10 on impacted communities;

11 (ii) a cost analysis of the closing of a barracks including, but not limited to, the financial  
12 impact on impacted communities; and

13 (iii) a thorough appraisal of the building, land and structures on the property where the  
14 barracks is located including, but not limited to, annual associated maintenance costs.

15 (b) The report shall be filed with the clerks of the senate and house of representatives not  
16 later than 60 days after notice of a proposed closure of a state police barracks has been provided  
17 to the clerks and the clerks shall forward the report to the president of the senate, the speaker of  
18 the house of representatives and members of the senate and house of representatives whose  
19 districts include an impacted community.
