Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- Section 1. Section 1 of chapter 150E of the General Laws, as appearing in the 2014
- 2 Official Edition, is hereby amended by adding to the end of the seventh paragraph, titled
- 3 "Employer" or "public employer", the following sentence:- In the case of employees of the
- 4 committee for public counsel services, employer shall mean the committee for public counsel
- 5 services or its designee.
- 6 Section 2. Section 7 of chapter 150E of the General Laws as appearing in the 2014
- 7 Official Edition is hereby amended by striking the word "or" before the word "commission" and
- 8 inserting after the word "commission" in line 15 the following words:- or the committee for

- Section 3. Section 7 of chapter 150E of the General Laws as appearing in the 2014
- Official Edition is hereby amended by striking the word "and" before the words "the state lottery

- 12 commission" and inserting after the word "commission" in line 32 the following words:- and
- 13 committee for public counsel services.
