Resolve relative to Southern Middlesex County.

1 Resolved,

2 That a special commission is hereby established to make an investigation and study  
3 relative to identify and evaluate potential sites suitable for the location of a replacement jail  
4 facility in Southern Middlesex County, consistent with chapter 304 of the acts of 2008. The  
5 commission shall evaluate whether such sites are appropriate to adjoin facilities to house related  
6 criminal justice functions, including courts, pre-arraignment lockup facilities and special  
7 population facilities.

8 The special commission shall also identify and evaluate potential sites in Southern  
9 Middlesex County suitable for the placement of a correctional facility to house female pretrial  
10 detainees and female offenders sentenced to incarceration in the house of correction for 2½ years  
11 or less. The commission shall document the needs of the communities in the vicinity of such  
12 sites and of the individuals in those communities, and make recommendations relative to the  
13 most efficient and effective investment of public resources to meet all of those needs.

14 The commission shall include the following officers or their designees: the secretary of  
15 public safety and security, who shall chair the commission; the secretary of administration and  
16 finance; the Middlesex sheriff; the administrative office of the trial court; the Middlesex superior  
17 court clerk; the commissioner of capital asset management and maintenance; the Middlesex  
18 district attorney; chief counsel of the committee for public counsel services; 1 member of the  
19 senate appointed by the president; and 1 member of the house of representatives appointed by the  
20 speaker. Members not otherwise subject to chapter 268A of the General Laws by virtue of their  
21 public positions shall not be considered to be special state employees for purposes of said  
22 chapter 268A on account of their service on the commission.

23           The commission shall report its findings and recommendations to the governor and the  
24 clerks of the House of Representatives and the Senate not later than August 1, 2014.
