An Act relative to the veteran allowance for public retirees.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1	SECTION 1. Section 5 of Chapter 32 of the General Laws, as appearing in the 2016
2	Official Edition, is hereby amended in subsection (2), paragraph (b) by inserting in line 138 after
3	the word "dollars" the following words:- ",or upon acceptance of paragraph (b 1/2) fifty dollars,"
4	SECTION 2. Said paragraph is further amended by deleting in line 140 the words "in any
5	case" and inserting in place thereof the following words:- "or upon acceptance of paragraph (b
6	1/2) one thousand dollars."
7	SECTION 3. Subsection (2) of said section is hereby further amended by inserting the
8	following new paragraph:-

9 (b 1/2) Upon acceptance of this provision by a retirement system, any member of Group 10 1 or group 2 or Group 4, who is a veteran as defined in section one, shall receive, in lieu of 11 paragraph (b), an additional yearly allowance of fifty dollars for each year of creditable service 12 or fraction thereof; provided, that the total amount of said additional retirement allowance shall 13 not exceed one thousand dollars in any case. Acceptance of this provision by a retirement system 14 shall be by a majority vote of the board of each such system, subject to the approval of the 15 legislative body. For the purposes herein, "legislative body" shall mean, in the case of a city, the 16 city council in accordance with its charter, in the case of a town, the town meeting, in the case of 17 a county, the county retirement board advisory council, in the case of a region, the regional 18 retirement board advisory council, in the case of a district, the district members, and, in the case 19 of an authority, the governing body. Acceptance shall be deemed to have occurred upon the 20 filing of a certification of such votes with the commission. For purposes herein, the state 21 teachers' and state employees' retirement systems shall be deemed to have accepted this 22 provision. 23 SECTION 4. Section 7 of said Chapter is hereby amended in subsection (2) in paragraph

(f) Upon acceptance of this provision by a retirement system, any member of Group 1 or
group 2 or Group 4, who is a veteran as defined in section one, shall receive, in lieu of paragraph
(b), an additional yearly allowance of fifty dollars for each year of creditable service or fraction

31	thereof; provided, that the total amount of said additional retirement allowance shall not exceed
32	one thousand dollars in any case. Acceptance of this provision by a retirement system shall be by
33	a majority vote of the board of each such system, subject to the approval of the legislative body.
34	For the purposes herein, "legislative body" shall mean, in the case of a city, the city council in
35	accordance with its charter, in the case of a town, the town meeting, in the case of a county, the
36	county retirement board advisory council, in the case of a region, the regional retirement board
37	advisory council, in the case of a district, the district members, and, in the case of an authority,
38	the governing body. Acceptance shall be deemed to have occurred upon the filing of a
39	certification of such votes with the commission. For purposes herein, the state teachers' and state
40	employees' retirement systems shall be deemed to have accepted this provision.
41	SECTION 6. Section 26 of said Chapter 32 is hereby amended in subsection (3) in
42	paragraph (c) by deleting in line 131 the dollar amount "\$15" and inserting in place thereof the
43	following dollar amount:- "\$50".
44	SECTION 7. Said paragraph is further amended by deleting in line 134 the dollar amount
45	"\$300" and inserting in place thereof the following dollar amount:- "\$1,000".
46	SECTION 8. The provisions of this act shall be prospective from the date of acceptance
47	of this act and shall not entitle a member, who is entitled to the benefits provided under this act,
48	to any retroactive benefits.
