**The Commonwealth of Massachusetts**

**In the Year Two Thousand Thirteen**

An Act to improve the promotion of tourism throughout the Commonwealth.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Section 13H of chapter 23A of the General Laws, as appearing in the 2010  
2 Official Edition, is hereby amended by inserting after the words, "Worcester County Convention  
3 and Visitors Bureau," the following:- Blackstone Valley Chamber of Commerce, Chamber of  
4 Central Mass South;

5 SECTION 2. Section 43 of chapter 23G of the General Laws, as so appearing, is hereby  
6 amended by striking out said section and inserting in place thereof the following new section:-

7 Section 43. There shall be a cultural facilities fund advisory committee, the function of  
8 which shall be strictly advisory to the agency in connection with the management and operation  
9 of the Massachusetts Cultural Facilities Fund. The committee shall consist of the following  
10 members: the director of the Massachusetts cultural council or his designee; the director of the  
11 office of travel and tourism or his designee; the director of the agency or his designee; and 8  
12 members to be appointed by the governor, 1 of whom shall have expertise in construction. In  
13 appointing members, the governor shall ensure that each of the following geographic regions of  
14 the commonwealth is represented: the central area, the north central area, south central area, the  
15 greater Boston area, the metro-west area, the northeast area, the southeast area and the western  
16 area. All members shall be appointed for a term of 5 years, may be reappointed, and shall serve  
17 without compensation, but may be reimbursed from the Fund for ordinary and reasonable in-state  
18 travel expenses. The committee may meet as often as the members may determine, but shall  
19 meet at least bi-annually, or at such other intervals as may be established by the agency in order  
20 to review recommendations made by the Massachusetts cultural council, or such other qualified  
21 organization with which the agency contracts, with respect to the Fund and to make any advisory

22 recommendations with respect thereto to the agency. Subsection (d), and subsections (f) to (i)  
23 inclusive and subsection (l) of section 2 shall apply to the members and affairs of the committee.  
24 All applications for grants or loans recommended by the Massachusetts cultural council or other  
25 such organization with whom the agency may contract shall be reviewed by the committee. The  
26 committee shall then issue findings and recommendations to the agency as to which applications  
27 should be approved. Only those applications that are recommended by the committee for  
28 approval shall be considered by the agency's board of directors for final approval. If the  
29 agency's board of directors votes to deny any recommended approval, the agency shall, within  
30 30 days of such action, provide the applicant a written explanation for such denial.
