An Act Occupational Healthcare Act.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 Emergency Preamble-
- 2 "Whereas, the deferred operation of this act would tend to defeat its purpose, which is
- 3 forthwith to consolidate time and expense involved in the administration of Occupational
- 4 Healthcare, therefore, it is hereby declared to be an emergency law, necessary for the immediate
- 5 preservation of the public convenience."
- 6 Occupational Healthcare Act Trust and its appointed commissioner is authorized to
- 7 provide unused and unlimited treasury notes by the treasury on an ongoing basis for the
- 8 following facilities and services:
- 9 Policy to Provide unlimited access, coverage and accessibility to Common Care health
- 10 services and facilities.

13	2.Common Care Evaluation and Voucher Provider Clinical Practices Include Clinical
