By Mr. Rosenberg, a petition (subject to Joint Rule 12) (accompanied by bill, Senate, No.) of Stanley Rosenberg and Ellen Story for legislation to provide for a labor/management workplace and education trust fund at the University of Massachusetts Amherst. Higher Education.

The Commonwealth of Massachusetts

In the Year Two Thousand Eleven

An Act providing for a labor/management workplace and education trust fund at the University of Massachusetts Amherst.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. For the purpose of this act the following words shall have the following meanings:
- 2 "Bank" shall mean a national bank, trust company, or banking company as defined in section 34
- 3 of chapter 29 of the General Laws.
- 4 "Employer" shall mean the University of Massachusetts Amherst;
- 5 "Employee" shall mean any person employed by the University of Massachusetts Amherst and
- 6 include the collective bargaining units represented by the unions;
- 7 "Labor/Management Workplace Education Program" or "program" shall mean the joint labor
- 8 and management educational partnership between the University of Massachusetts Amherst and
- 9 the employee unions;

- 10 "Union" shall mean the American Federation of State, County, and Municipal Employees
- 11 Council 93 and its affiliated local American Federation of State, County, and Municipal
- 12 Employees Local 1776; the Massachusetts Teachers Association and its affiliated associations,
- 13 the University Staff Union, and the Professional Staff Union, Unit B.
- 14 SECTION 2. (a) There shall be at the University of Massachusetts Amherst a trust fund to be
- 15 known as the Labor/Management Workplace and Education Trust Fund, hereinafter referred to
- 16 as the "fund," to support the operations and activities of the University of Massachusetts
- 17 Labor/Management Workplace Education Program.
- 18 (b) The fund shall be overseen by a board of trustees, hereinafter referred to as the "board,"
- 19 which shall consist of 6 members: 3 of whom shall be selected by the employer and 3 of whom
- 20 shall be selected by the union; provided however, that no two union board members shall be
- 21 from the same union. The board shall be co-chaired by 2 of the trustees, 1 selected by the
- 22 employer trustees and 1 selected by the union trustees. The trustees shall be responsible for
- 23 transferring to a bank selected by the board all contributions, including, but not limited to,
- 24 employer contributions, donations, funds, stocks, share certificates, bonds, securities, and all
- 25 other obligations.
- 26 (c) The trustees shall use all funds exclusively in support of the program; provided, that the
- 27 board may make appropriations necessary to administer the fund; including, the employment of
- 28 administrative, legal, accounting, expert, consultative, and clerical assistance, the purchase or
- 29 lease of buildings and/or land, and the purchase or lease of materials, supplies, and equipment
- 30 the trustees determine necessary in the performance of their duties. The trustees shall serve

- 31 without compensation but may be reimbursed for all reasonable and necessary expenses which
- 32 they may incur in the performance of their duties.
- 33 (d) The trustees shall keep true and accurate books of accounts and records of all transactions of
- 34 the fund, and will cause said books to be audited by a certified public accountant each fiscal
- 35 year. The accountant shall be made available to the employer and the union and shall submit a
- final audit in writing to the trustees. Any employee or beneficiary shall be permitted to inspect
- 37 the books and records maintained by the trustees, provided that, the request is at a reasonable
- 38 time and place as determined by a majority of the trustees and that the inspection does not
- 39 interfere with the operation of the fund. Upon request of the employer, the trustees
- 40 (e) If a civil action is brought against a trustee the trustee shall be indemnified for all expenses
- 41 incurred in the defense of the action and shall be indemnified for damages if the claim arose out
- 42 of acts performed by the trustee while acting within the scope of the trustee's official duties;
- 43 provided, however, that a trustee shall not be indemnified for expenses incurred in the defense of
- 44 an action, or damages awarded in an action, in which there is shown to be a breach of fiduciary
- 45 duty, an act of willful dishonesty or an intentional violation of law by the member. Such
- 46 indemnification shall be paid from amounts held in the fund.
- 47 SECTION 3. This act shall go into effect upon its passage.
