AN ACT RELATIVE TO EVALUATING AND ENHANCING QUALITY PHYSICAL EDUCATION.

Be it enacted by the Senate and House of Representatives in General Court assembled,

And by the authority of the same, as follows:

8 be appointed by the speaker of the house of representatives, 1 of whom shall be appointed by the 9 minority leader in the senate, and 1 of whom shall be appointed by the minority leader in the house of representatives, 1 of whom shall be the commissioner of higher education, or his 10 11 designee, 1 of whom shall represent the Massachusetts association for health, physical education, recreation and dance, 1 of whom shall be a representative of the american heart association, 1 of 12 13 whom shall be a representative of the american diabetes association, 1 of whom shall be a 14 representative of the Massachusetts parent teacher association, 1 of whom shall be a representative of the Massachusetts public health association, and 1 one of whom shall be a 15 16 representative of the Massachusetts academy of pediatrics. All appointed members shall be individuals with a demonstrated commitment to physical education and activity. The council 17 18 shall advise the commissioner and make recommendations for schools to promote participation 19 in quality physical education and activity.

20 **SECTION 3.** The commissioner of elementary and secondary education, in consultation 21 with the commissioner of public health, shall investigate and study physical education standards, 22 practices and instruction provided to students in grades kindergarten to 12, inclusive, for each 23 public school. The study shall include: a report on how each public school is providing 24 curriculum-based quality physical education, school physical education offerings, including the duration of each class and the number of days per week the class meets each year, and the 25 26 amount of time students participate in recess each week, including space allotted to recess in 27 each school. The commissioner of elementary and secondary education shall consult with the 28 physical education and activity advisory council and report to the general court the results of its 29 investigation and study for each public school and its recommendations, if any, together with 30 drafts of legislation necessary to carry out such recommendation, by filing the same with the

- 31 governor, the clerks of the senate and house who shall forward the same to the chairs of the joint
- 32 committee on education and the chairs of the joint committee on public health on or before July
- 33 31, 2011.
