An Act authorizing the town of Wareham to grant an additional license for the sale of malt beverages not to be drunk on the premises..

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. (a) Notwithstanding section 17 of chapter 138 of the General Laws, chapter  
2 236 of the acts of 2018, as amended by chapter 414 of the acts of 2018, or section 12 of said  
3 chapter 138 to the contrary, the licensing authority of the town of Wareham may grant 1  
4 additional license for the sale of malt beverages containing malts produced on premises not to be  
5 drunk on the premises pursuant to section 15 of said chapter 138 to Stone Path Malt, LLC,  
6 located at 11 Kendrick Road in the town of Wareham. The license shall be subject to all of said  
7 chapter 138, except section 17.

8           (b) The licensee shall comply with such requirements and conditions as the licensing  
9 authority of the town of Wareham shall deem appropriate, including, but not limited to reporting  
10 on the brands of malt beverages sold pursuant to any license held by the licensee with as  
11 frequently as required by the licensing authority. Failure to comply with such requirements and  
12 conditions shall result in revocation of the license granted under this act.

13           (c) The licensing authority shall not approve the transfer of the license granted under this  
14 act to any other location, but it may grant the license to a new applicant at the same location if  
15 the applicant files with the licensing authority a letter from the department of revenue and a letter  
16 from the department of unemployment assistance indicating that the license is in good standing  
17 with those departments and that all applicable taxes, fees and contributions have been paid.

18           (d) If a licensee terminates or fails to renew a license granted under this act or any such  
19 license is cancelled, revoked or no longer in use, it shall be returned physically, with all of the  
20 legal rights, privileges and restrictions pertaining thereto, to the licensing authority and the  
21 licensing authority may then grant the license to a new applicant at the same location under the  
22 same conditions as specified in this act."

23           (e) The license granted under this act shall be issued within 1 year after the effective date  
24 of this act; provided, however, that a license originally granted within that time period may be  
25 granted to a new applicant under subsections (c) or (d) thereafter.

26           SECTION 2. This act shall take effect upon its passage.
