**In the One Hundred and Ninety-First General Court
(2019-2020)**

An Act providing for the renaming of the board of selectmen to select board in the town of Hubbardston.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Article 1 of the charter of the town of Hubbardston, which is on file in the
2 office of the archivist of the commonwealth, as provided in section 12 of chapter 43B of the
3 General Laws, is hereby amended by striking out the words “board of selectmen”, each time they
4 appear. and inserting in place thereof, in each instance, the following words:- select board.

5 SECTION 2. Section 1-4-2 of section 4 of article 1 of said charter is hereby amended by
6 adding the following sentence:- The select board shall have and exercise all the powers duties
7 vested in boards of selectmen under the General Laws or by vote of town, unless otherwise
8 provided herein.

9 SECTION 3. Article 2 of said charter is hereby amended by striking out the words “board
10 of selectmen”, each time they appear, and inserting in place thereof, in each instance, the
11 following words:- select board.

12 SECTION 4. The title of section 1 of article 3 of said charter is hereby amended by
13 striking out the words “Board of Selectmen” and inserting in place thereof the following words:-
14 the Select Board.

15 SECTION 5. Said section 1 of said article 3 is hereby further amended by striking out the
16 words “board of selectmen”, the second to sixth, inclusive, times they appear, and inserting in
17 place thereof, in each instance, the following words:- select board.

18 SECTION 6. The title of section 2 of said article 3 of said charter is hereby amended by
19 striking out the words “Board of Selectmen” and inserting in place thereof the following words:-
20 the Select Board.

21 SECTION 7. Said section 2 of said article 3 of said charter is hereby further amended by
22 striking out the words “board of selectmen”, the second to fourth, inclusive, times they appear,
23 and inserting in place thereof, in each instance, the following words:- select board.

24 SECTION 8. Said section 2 of said article 3 of said charter is hereby further amended by
25 striking out the word “selectmen”, the third time it appears, and inserting in place thereof the
26 following words:- select board members.

27 SECTION 9. Said section 2 of said article 3 of said charter is hereby further amended by
28 striking out the word “selectmen”, the sixth time it appears, and inserting in place thereof the
29 following words:- select board member.

30 SECTION 10. Section 3 of said article 3 of said charter is hereby amended by striking out
31 the words “board of selectmen”, each time they appear, and inserting in place thereof, in each
32 instance, the following words: - select board.

33 SECTION 11. Section 4 of said article 3 of said charter is hereby amended by striking out
34 the words “board of selectmen”, each time they appear, and inserting in place thereof, in each
35 instance, the following words: - select board.

36 SECTION 12. Section 5 of said article 3 of said charter is hereby amended by striking out
37 the words “board of selectmen” and inserting in place thereof the following words: - select
38 board.

39 SECTION 13. Article 4 of said charter is hereby amended by striking out the words
40 “board of selectmen”, each time they appear, and inserting in place thereof, in each instance, the
41 following words:- select board.

42 SECTION 14. Section 4-5-2 of section 5 of said article 4 of said charter is hereby
43 amended by striking out the word “selectmen” and inserting in place thereof the following
44 words:- select board.

45 SECTION 15. Article 5 of said charter is hereby amended by striking out the words
46 “board of selectmen”, each time they appear, and inserting in place thereof, in each instance, the
47 following words:- select board.

48 SECTION 16. Article 6 of said charter is hereby amended by striking out the words
49 “board of selectmen”, each time they appear, and inserting in place thereof, in each instance, the
50 following words:- select board.

51 SECTION 17. Subsection (b) of section 2 of chapter 292 of the acts of 2012 is hereby
52 amended by striking out the words “board of selectmen” and inserting in place thereof the
53 following words:- select board.

54 SECTION 18. Subsection (c) of section 3 of said chapter 292 is hereby amended by
55 striking out the words “board of selectmen” and inserting in place thereof the following words:-
56 select board.

57 SECTION 19. Subsection (b) of section 7 of said chapter 292 is hereby amended by
58 striking out the words “board of selectmen” and inserting in place thereof the following words:-
59 select board.

60 SECTION 20. Subsection (b) of said section 7 of said chapter 292 is hereby amended by
61 striking out the word “selectman”, each time it appears, and inserting in place thereof, in each
62 instance, the following words:- select board member.

63 SECTION 21. Section 8 of said chapter 292 is hereby amended by striking out the words
64 “board of selectmen” and inserting in place thereof the following words:- select board.

65 SECTION 22. This act shall take effect upon its passage.
