An Act relative to adult family homes.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 71 of chapter 111 of the General Laws, as appearing in the 2010
2 Official Edition, is hereby amended by inserting, in line 5, after the words “a rest home” the
3 following:- “, adult family home,”; and

4 in line 22, after the words “rest home” the following:- “, adult family home,”; and

5 in line 74, after the words “rest home” the following:- “, adult family home,”; and

6 in line 80, after the words “rest home” the following:- “, adult family home,”; and

7 in line 86, after the words “rest home” the following:- “, adult family home,”; and

8 in line 121, after the words “rest home” the following:- “, adult family home,”; and

9 in line 128, after the words “rest home” the following:- “, adult family home,”; and

10 in line 134, after the words “rest home” the following:- “, adult family home,”; and

11 in line 138, after the words “rest home” the following:- “, adult family home,”; and

12 by inserting, in line 155, after the word “supervision.” the following:-

13 “An adult family home is defined as an institution where no more than 4 adults not
14 related to the licensee reside in which care, treatment or service above the level of room and
15 board but not including nursing care are provided to persons residing in the home as a primary
16 function of the place.”; and

17 in line 170, after the words “rest home” the following:- “, adult family home,”; and
18 in line 173, after the words “rest home” the following:- “, adult family home,”; and
19 in line 211, after the words “nursing home” the following:- “, adult family home,”; and
20 in line 266, after the words “rest home” the following:- “, adult family home,”; and
