Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Section 76 of chapter 54 of the General Laws, as so appearing in the 2008
- 2 Official Edition, is hereby amended by striking the section in its entirety and inserting the
- 3 following words:- Section 76. Each voter desiring to vote at a polling place shall provide a name,
- 4 residential address, and valid photo identification to one of the officers at the entrance to the
- 5 space within the guard rail, who shall thereupon distinctly announce the same. If such name is
- 6 found on the voting list, the election officer shall check and repeat the name and shall admit the
- 7 voter to the space enclosed by the guard rail and, in case of official ballots, other than those
- 8 marked "Challenged Ballots" as provided by section thirty-five A, are used, such voter shall be

- 9 given one ballot. The use of electronic means such as tape recording equipment or radio
- 10 broadcasting equipments for the recording or broadcasting of the names of the voters not yet
- 11 checked as having voted shall be prohibited.
- SECTION 2. Section 76B of chapter 54, as so appearing is hereby amended by striking
- 13 out after the words,
- 14 "suitable written identification", the following:- when so requested by
