An Act regulating campaign contributions..

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 13 of chapter 55, as appearing in the 1996 Official Edition, is
2 hereby amended by striking the first sentence thereof and inserting in place thereof the
3 following:- No person employed for compensation, other than an elected officer, by the
4 commonwealth or any county, city or town shall directly or indirectly solicit or receive any gift,
5 payment, contribution, assessment, subscription or promise of money or other thing of value for
6 the political campaign purposes of any candidate for public office or of any political committee,
7 or for any political purpose whatever, provided, however, that such persons may be members of
8 political organizations or committees and may solicit or receive contributions for a political
9 committee not organized on behalf of an individual candidate from persons other than other
10 public employees when such persons supervise and persons doing business with the

11 commonwealth or any city or town; and further provided that the solicitation and receipt of
12 contributions by and from public employees shall not take place while either the public employee
13 soliciting or receiving a contribution or any public employee from whom such a contribution is
14 solicited or received is on duty.

15 SECTION 2. Section fifteen of chapter fifty-five, as appearing in the 1996 Official
16 Edition, is hereby amended by striking the first sentence and inserting in place thereof the
17 following:- Except as provided in section thirteen, no officer, clerk, or other person in the
18 service of the commonwealth or of any county, city or town shall, directly or indirectly, give or
19 deliver to an officer, clerk or person in said service, or to any councillor, member of the general
20 court, alderman, councilman or commissioner, any money or other valuable thing on account of,
21 or to be applied to, the promotion of any political object whatever.
