The Commonwealth of Massachusetts

In the One Hundred and Eighty-Ninth General Court (2015-2016)

An Act to promote personal savings.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. Chapter 167F of the General Laws, as appearing in the 2014 Official
- 2 Edition, is hereby amended by inserting, in section 1, the following new definition:-
- 3 "Savings promotion raffle", a raffle conducted by a financial institution organized under
- 4 this chapter wherein the sole consideration required for a chance of winning designated prizes is
- 5 the deposit of a minimum specified amount of money in a savings account or other savings
- 6 program offered by said credit union.
- 7 SECTION 2. Section 2 of said chapter is hereby amended by inserting, after clause 33,
- 8 the following clause:-
- 9 34. To conduct a savings promotion raffle, provided that the bank (1) conducts the
- 10 savings promotion raffle in a manner that ensures that each entry has an equal chance of winning
- 11 the designated prize; (2) fully discloses the terms and conditions of the savings promotion raffle

- 12 to each qualified account holder; and (3) maintains records sufficient to facilitate an audit the savings promotion raffle program.
- SECTION 3. Chapter 171 of the General Laws, as so appearing, is hereby amended by inserting in section 1, the following new definition:-
- "Savings promotion raffle", a raffle conducted by a financial institution organized under this chapter wherein the sole consideration required for a chance of winning designated prizes is the deposit of a minimum specified amount of money in a savings account or other savings program offered by said institution.
- 20 SECTION 2. Said chapter 171 is further amended by inserting, after section 6A, the 21 following new section:-
- Section 6B. A credit union organized under this chapter may conduct a savings
 promotion raffle, provided that the credit union (1) conducts the savings promotion raffle in a
 manner that ensures that each entry has an equal chance of winning the designated prize; (2)
 fully discloses the terms and conditions of the savings promotion raffle to each qualified account
 holder; and (3) maintains records sufficient to facilitate an audit the savings promotion raffle
 program.
- The commissioner shall promulgate regulations as necessary to effectuate this section.
