- 9 amended by striking out, in line 8, the words "the city of Boston" and inserting in place thereof
- 10 the following words:-Suffolk county.
- SECTION 4. Said section 4 is hereby further amended by striking out, in line
- 12 9, the words "Suffolk County courthouse" and inserting in place thereof the following words:-the
- 13 Edward W. Brooke Courthouse.

14	SECTION 5. Said section 4 is hereby further amended by striking out, in line
15	11 the words "the city of Boston" and inserting in place thereof the following words:-Suffolk
16	county.

- SECTION 6. Section 8 of said chapter 185C, as so appearing, is hereby amended by striking out, in lines 4 and 5, the words "city of Boston" and inserting in place thereof the following:-Suffolk county.
- SECTION 7. Notwithstanding any general or special law or city ordinance to the contrary, whenever the words "city of Boston division of the housing court department" are used, such words shall refer to the Suffolk County division of the housing court department.
